## Completed Steps

- ~~Governor signed AB1487 (Chiu) bill to establish Bay Area Housing Finance Authority with STA Board Members' requested amendments~~
- ~~STA Board established Solano Housing Investment Partnership (SolHIP)~~
- ~~4C's authorized RHNA subdelegation process for forthcoming RHNA cycle on August 8th and appointed representative for ABAG-RHNA methodology committee.~~
- ~~Cities and County submitted letters to ABAG/MTC by Sept 16<sup>th</sup> regarding modifications to their existing PCA and PDA boundaries, and proposed new PCA, PDA, and PPAs~~
- ~~Informed 4C's members on State Budget Housing Trailer Bill (AB 101) which includes additional planning funds for Solano County~~
- ~~4C's Formed RHNA subdelegation for Solano county in Fall 2019~~
- ~~All 7 Cities and Solano County joined SolHIP Partnership with STA~~



## Next Steps

- Cities and County developing scopes of work and requesting SB2 planning funding from HCD to prepare for housing and jobs production - due November 2019**
- SolHIP partnership to develop funding agreements and individual work plans with participating agencies**
- Solano County and Solano EDC to conduct the 2020 Census campaign**
- Solano County and 4C's to monitor and participate in RHNA Methodology Committee starting in October**

## Future Items

- Work with your local transit operator to update short-range transit plans in FY 2020 with focus on linking PDAs, housing, jobs, regional transit service, and sustainability**
- Cities and County to obtain additional Planning Funds included in FY2019-20 Budget Trailer Bill**
- Participate in forthcoming RHNA allocation process covering 2022-2030 RHNA cycle**
- Cities and County to adopt resolutions for the RHNA subdelegation process for Solano County**
- STA to coordinate with ABAG/MTC on OBAG 3 funding for PDA & PPA implementation (8 years)**
- Cities and County to implement SB2 planning funds scopes of work**
- SolHIP partnership to develop housing production funding strategies for participating cities and County**
