

STA'S COMMITMENT

The STA was created in 1990 through a Joint Powers Agreement between the cities of Benicia, Dixon, Fairfield, Rio Vista, Suisun City, Vacaville, Vallejo and the County of Solano to serve as the Congestion Management Agency for Solano County. The STA is responsible for countywide transportation planning and coordination, delivering priority projects, the programming federal, state and regional transportation funds, administration of the Solano Napa Commuter Information program and managing two transit services.







STA PLANS

Solano Comprehensive Transportation Plan

The focus of the Solano Comprehensive Transportation Plan is to address the County's continuing growth by addressing transportation needs on Solano County roads, highways and freeways and to provide transit, bicycle and pedestrian alternatives. This year the STA completed its work on this stragetic planning document that will provide the vision and framework for Solano County's transportation decisions for the next 25 years. The plan focuses on funding availability, projected growth, traffic and transportation system impacts. The purpose of the planning process was to develop a countywide transportation vision, coordinate between different modes, establish short and long range priorities, and develop a funding plan for identified projects and programs.

Three subcommittees were established to oversee the planning process:

1. Arterials, Highways and Freeways; 2. Transit (rail, ferry and bus); and 3.

Alternative Moder (biles, twile TLC and rides have).

A Steering Committee

Alternative Modes (bikes, trails, TLC and rideshare). A Steering Committee coordinated between modes. Public input was solicited during the planning process with 14 public input meeting being held

throughout the county. The process included the development of policies and proposals for each of the three elements (roads, transit and alternatives). Special attention was focused on the regional and local road needs, ensure transit for the elderly and disabled, commuter rail, and

Transportation for Livable Communities (TLC) Enhancement candidate projects. A The Solano Comprehensive Transportation Plan was adopted by the STA Board in May 2002.

Expenditure Plan for Measure E


In an effort to provide local funding to help address Solano County's \$3 billion shortfall over the next 30 years, the STA developed a Countywide Transportation Expenditure Plan and the Solano County Board of Supervisors placed Measure E on the Ballot. On November 7, 2002, 60% of Solano County voters supported Measure E, the proposed 1/2 cent transportation sales tax for Solano County. Unfortunately, it did not receive the required 2/3 majority necessary for passage. The measure was supported by all seven Solano County cities and the county and would have addressed many of the needs identified in the STA Comprehensive Transportation Plan. The measure would have raised approximately \$1 billion over 20 years to provide funding for the following priority projects:

- I-80/I-680/SR 12 Interchange
- I-80 Corridor Improvements
- SR 12 Improvements
- SR 113 Improvements
- Senior and Disabled Transit
- Express Bus Service

- Baylink Ferry Service
- Local Transit
- Commuter Rail Service to BART
- Commuter Rail Service to Sacramento
- Expanded Capitol Corridor Rail Service

A 21 member Citizen's Oversight Committee was appointed to oversee the expenditure of the anticipated revenues and review specific projects and make recommendations on funding mechanisms. The STA is planning to work with the public and key community leaders to consider the

development of a new transportation plan that may be placed on the ballot in the future.



I-80/I-680/I-780 Corridor Study

In early 2002, the STA completed Segment 1 of the I-80/I-680/I-780 Corridor Study, a comprehensive assessment and prioritization of key highway issues on the entire length of the corridor. The Segment 1 study concentrated on the I-80/I-680/SR 12 Interchange area. The other six segments of the Corridor Study will be completed in 2003-04. The completed study will identify transportation improvements along the entire interstate system in Solano County to meet the transportation needs for the next 25 years.

Highway 12 Safety Improvements

Highway 12 is an important east-west route that connects Solano County to Napa and Sonoma counties to the west and I-80 to Rio Vista to the east. The Highway 12 Major Investment Study, completed in 2001, proposed various near and long-term improvements needed on the segment of the route from I-80 to the Sacramento River.

The STA has worked closely with Caltrans to program over \$35 million of State Highway Operations and Protection Program (SHOPP) funding to correct safety and operational issues on Highway 12 from Suisun City to Rio Vista. During 2002, the Round Hill Creek Bridge project located on Highway 12 near Highway 113 was completed and major safety improvements from Scandia Road to Currie Road are now programmed for 2006-08 through the SHOPP.



PROJECT DELIVERY

New Benicia-Martinez Bridge

The Benicia/Martinez Bridge expansion project provides significant improvements to one of the major regional connections between Solano County, Contra Costa County and other Bay Area destinations. The STA continues to work with the Metropolitan Transportation Commission (MTC), Caltrans, the Contra Costa Transportation Authority and the City of Benicia to address issues concerning the construction of the new northbound bridge span. A new 17 booth toll plaza will be constructed on the Contra Costa side and a new interchange at I-680/I-780 will be provided in Solano County. The new bridge will have five northbound lanes, four southbound lanes, a new pedestrian and bicycle lane, and the capacity for future rail service. The project is currently under construction with the new span



scheduled to open in 2005-06. The total cost for this project is estimated to be ____ and is funded by Regional Measure 1 that was passed by Bay Area voters in 1988.



Carquinez Replacement Bridge

The project inproves the other major connection between Solano County and Contra Costa County and includes the replacement of the 1927 span and the seismic retrofit of the eastbound span that was constructed in 1958 ensuring both spans meet traffic safety standards and correct roadway deficiencies. The new span will include three westbound lanes, one HOV lane and a pedestrian/bicycle lane. STA continues to work with Caltrans, MTC and the City of Vallejo to address local issues. The total cost for this project is estimated to be \$340 million and is also funded by Regional Measure 1 funds. The project is scheduled for completion by the end of 2003.

I-80/I-680/SR 12 Interchange

The completion of the new Benicia/Martinez Bridge has created an urgency in accelerating the delivery of this project. The STA Board of Directors has designated the I-80/I-680/SR 12 Interchange the number one transportation project within Solano County. Through the collective efforts of local and state elected officials, the total funding available for this project increased from \$38 million to \$73 million in 2002. The total cost of this interchange is expected to be at least \$800 million and the STA is working with Caltrans and the Federal Highway Administration to plan construction in phases as funds become available. The STA was successful in obtaining an additional \$20 million in state funds to further advance the I-80/I-680/SR 12 Interchange project, including a new truck climbing lane on westbound SR 12 Also being studied are the Cordelia Truck Scales that are situated in on both sides of the freeway and will have a significant impact on the operation of the interchange, and the



project that will connect Abernathy Road to SR 12 west in order to provide local traffic an alternative to I-80 in this area.



In order to maintain an acceptable level of service at the I-80/I-680/SR 12 Interchange, various alternative concepts are being analyzed by a project team consisting of STA, Caltrans and STA member agencies countywide. Community input is important as various alternatives and environmental studies are prepared and considered. The I-80/I-680/SR 12 Interchange project is one of STA's four Priority Projects for federal funding.

I-80/I-680 Auxiliary Lane

The I-80/I-680 Auxiliary Lane Project is the most immediate opportunity to provide temporary relief from the anticipated increase in congestion that will result from the completion of the Benicia/Martinez Bridge project. This project is fully funded and Caltrans District 4 plans to start construction in Gsll 2003. This project will construct a fifth through-lane in each direction on I-80 between I-680 and SR 12 (East). The project also expands the existing one lane connector ramp (to/from I-680 from/to I-80) to two lanes. The \$19 million project is scheduled for completion in 2005 (prior to the completion of the new Benicia-Martinez bridge span).

State Route 37/29 Interchange

The State Route 37 Project represents a two decade-old Solano County priority project that was accelerated with the closure of Mare Island. Because of the unique and special nature of this project and its proximity to waterways, the White Slough Specific Area Plan was prepared and approved by the Bay Conservation and Development Commission (BCDC) before permits could be issued.

Phase I of this project will restore tidal wetlands at Guadalcanal Village and mitigate the loss of wetlands due to the proposed construction, Phase II and III will construct a four lane freeway in each direction from the Napa River Bridge to Diablo Street and a cloverleaf interchange at Highway 37/29. Construction of all phases is underway. Total cost of this project is \$119 million. Project completion is scheduled for 2005.

Jepson Parkway

In order to address congestion on I-80 and the lack of local arterials, the Jepson Parkway Concept Plan was developed by the STA, the cities of Fairfield, Suisun City, Vacaville, and Solano County. The Concept Plan provides a comprehensive, innovative and coordinated strategy for developing a multi-modal corridor linking land use and transportation.

The multi-modal Jepson Parkway roject connects the I-80 Leisure Town Road interchange in Vacaville with Highway 12 in Suisun City. The four-lane parkway is designed to provide intra-county mobility for Solano County residents. The project links the existing road segments of Leisure Town, Vanden, and Walters Roads and includes three bridges, railroad grade separations, traffic signals and improved intersections.

In 2002, an additional \$10 million of State Transportation Improvement Program (STIP) funds were awarded to various segments of the Jepson Parkway project. This additional funding will ensure that the next two phases of the project (the Walters Road widening in Suisun City and the new Leisure Town Road Widening in Vacaville) will be constructed in 2003-04 and 2004-05, respectively.

The Draft Environmental Impact Study was begun in the summer of 2001 with a draft EIR/S to be completed by the Spring of 2004 and final certification expected in 2005. The completion date of the entire project is expected by 2010 with several segments to be completed by 2007-08.

The Jepson Parkway project is one of STA's four Priority Projects for federal funding.

Highway 12 - Jameson Canyon

In 2002, the STA successfully joined with the Napa County Transportation Planning Agency (NCTPA) to secure an additional \$2 million (\$9 million total secured to date) in state funds to complete environmental and design work for the realignment and widening of Highway 12 between I-80 in Solano County and Highway 29 in Napa County. The environmental study for the project is scheduled to be completed by 2005.







Capitol Corridor Intercity Rail Service

Since the Capitol Corridor Joint Powers Authority was formed in 1998, the STA has been an active member in the planning of current and future intercity rail service. The Capitol Corridor Rail service operates daily between Sacramento, Oakland and San Jose and has become a viable intercity commute alternative for business and recreational travelers. The Suisun City station ridership has increased by 76% with a systemwide increase of 54%.

To prepare for the anticipated growth in ridership, the STA Board of Directors provided STIP (state) funds to initiate the station designs for proposed stations in

Fairfield/Vacaville, Benicia and Dixon.

The Capitols obtained state operating funds to add a 10th and 11th daily train to the system in 2002. The STA is supporting state funding for specific operational

improvements needed to improve and expand service in Solano County. The design and construction of the Fairfield/Vacaville Intermodal Train Station is one of STA's four priority projects for federal funding. The STA has obtained state funds to more than double the existing parking at the Suisun City Station.

Three commuter rail studies were commenced to study the feasibility of providing for potential service between Solano County and BART, Dixon-Sacramento-Auburn and Solano-Napa Counties.

Vallejo Baylink Ferry Service...


In 2002, the STA continued to support the most successful ferry service in the Bay Area. During 2002 a fourth high-speed board was ordered. The addition of the new ferry is projected to increase the annual patronage by 500,000 in 2004-05. STA's collaboration with Vallejo helped provide \$10 million in state and \$2 million in federal funds for a new fast ferry boat. The system has consistently averaged over 50% farebox recovery since 1992 and in 1999/2000 recorded a cost recovery rate of 75%.

The STA Board traveled to Washington DC in March 2002 to secure \$2 million in federal funds for the proposed Vallejo Intermodal Station. The planned station will be the primary transit terminal in the North Bay, facilitating congestion free transit for 5,000 daily ferry riders. The facility will provide 1,200 off street parking spaces, upgrades to local and regional bus transfer facilities, bicycle facilities and pedestrian connections between downtown and the Vallejo Ferry Terminal.

The Vallejo Intermodal Station is also one of STA's four priority projects for federal funding.

Solano Napa Commuter Information...

The Solano Napa Commuter Information (SNCI) Program has been part of the STA since July 2000. As part of MTC's Regional Rideshare Program, the SNCI program has provided rideshare and transit information and services to Solano County residents for over 20 years and to Napa County residents since 1998. The SNCI program is a partnership between the STA, Napa County Transportation Planning Agency (NCTPA), the Metropolitan Transportation Commission (MTC) and the Bay Area Air Quality Management District (BAAOMD).

Solano County commuters continue to have the longest average commutes and the highest percentage of car/vanpooling in the Bay Area. The SNCI program provides not only carpool and vanpool matching, and transit and

support services, but also comprehensive transportation information. SNCI staff work closely with transit operators to provide up-to-date local and regional bus, rail, and ferry information for commute and non-commute trips. Bicycling, rideshare incentives, park and ride lot information and more are available by calling SNCI at (800) 53-KMUTE.

Throughout the year, the program promotes the use of alternative transportation to individuals and organizations. One avenue for accomplishing this is by working with Solano and Napa employers and others in the business community. Other methods include offering commute incentives to Solano County's
















Total TEA-21 Federal Funds Obligated(FY's 1998-2003) = \$23.7 Million




