Elizabeth Richards reviewed the background and purpose for the Solano Mobility Study Plan for Older Adults and People with Disabilities, as well as project status. She outlined the top countywide challenges and discussed community priority solutions, as well as significant common issues and broad solutions. She presented near, medium and long term strategies, and concluded with next steps.

#### C. Solano County Transit (SolTrans) Update

By: Mandi Renshaw, SolTrans

Mandi Renshaw reviewed SolTrans policies in response to COVID-19 pandemic. She discussed COVID-19 service expansion for SolanoExpress, local routes, paratransit effective July 5, 2020; however, school tripper routes suspended until further notice. Concerns from the previous PCC meeting relating to mobility device charging capabilities on paratransit vehicles, paratransit's cleaning process in between trips, and lighting at bus stops were addressed. SolTrans transit service center expansion was also announced.

and the proposed claim from the City of Vacaville and the City of Fairfield are within the parameters of available TDA funds.

#### Recommendation:

Forward a recommendation to MTC to allocate funds based on the approved July 2020 TDA Matrix for FY 2020-21 which includes the TDA Claim for the City of Vacaville (City Coach) and the City of Fairfield (FAST) as shown in Attachment B; and Authorize the Executive Director to request that MTC shift \$150,000 in RM2 Funds from the Green Express to the Red Line for FY 2020-21 and FY 2021-22.

October 2020 – Dixon Readi Ride and Rio Vista Delta Breeze (RVDB)

#### **Background:**

The Transportation Development Act (TDA) was enacted in 1971 by the California Legislature to ensure a continuing statewide commitment to public transportation. This law imposes a one- quarter-cent tax on retail sales within each county for this purpose. Proceeds are returned to counties based upon the amount of taxes collected, and are apportioned within the county based on population. To obtain TDA funds, local jurisdictions must submit requests to regional transportation agencies that review the claims for consistency with TDA requirements. Solano County agencies submit TDA claims to the Metropolitan Transportation Commission (MTC), the Regional Transportation Planning Agency (RTPA) for the nine Bay Area counties.

The Solano FY 2020-21 TDA fund estimates by jurisdiction are shown on the attached MTC Fund Estimate (Attachment A). MTC recently updated the Fund Estimate to address the FY 2019-20 revenue reductions resulting from the COVID-19 pandemic. MTC will update the FY 2020-21 revenue estimates this fall to reflect lower sales tax receipts due to the pandemic.

TDA funds are shared among agencies to fund joint services such as SolanoExpress intercity bus routes and Intercity Taxi Scrip Program. To clarify how the TDA funds are to be allocated each year among the local agencies and to identify the purpose of the funds, the STA works with the transit operators and prepares an annual TDA matrix. The TDA matrix is approved by the STA Board and submitted to MTC to provide MTC guidance when reviewing individual TDA claims.

The cost share for the intercity routes per the Intercity Funding Agreement is reflected in the TDA Matrix. The intercity funding process includes a reconciliation of planned (budgeted) intercity revenues and expenditures to actual revenues and expenditures. In this cycle, FY 2018-19 actual amounts were reconciled to the estimated amounts for FY 2018-19. The reconciliation amounts and the estimated amounts for FY 2020-21 are merged to determine the cost per funding partner.

#### **Discussion:**

For FY 2020-21, the following TDA claim is being brought forward for review:

#### **Dixon Readi Ride**

Dixon is requesting \$526,642 in TDA funds for FY2020-21. This amount includes \$1,177 State of Good Repair (SGR) funding and \$1,552 Low Carbon Transit Operations Program (LCTOP) funding swapped with Fairfield Suisun Transit (FAST). The full requested amount will be used for operations. Dixon's TDA claim amounts are included in Attachment B.

#### Rio Vista Delta Breeze

RVDB is requesting \$345,774 in TDA funds for FY2020-21. This amount includes \$1,186 State of Good Repair (SGR) funding and \$1,564 Low Carbon Transit Operations Program (LCTOP) funding swapped with SolTrans. The full requested amount will be used for operations. Rio Vista's TDA claim amounts are included in Attachment B.

#### **Fiscal Impact:**

No additional financial impact to STA as these claim amounts are consistent with the proposed FY 2020-21 STA Budget. The STA Board approval of the October 2020 TDA matrix provides the guidance needed by MTC to process the TDA claim submitted by STA from their local operators' TDA funds.

#### **Recommendation:**

Review and forward a recommendation to STA Board and MTC to approve a TDA Claim for Dixon in the amount of \$526,642 and Rio Vista in the amount of \$345,774.

RE: Expansion of Medical Trip Concierge (GoGo) Program with CARES Act Funding

#### **Background:**

The Medical Trip Concierge (GoGo) Program serves Solano County Older Adult residents (60+) by providing subsidized Uber and Lyft rides to and from medical appointments only. The riders pay either 20% or 40% of the cost depending on their income and, pre-COVID-19, are limited to 10 total trips per month. The Program, which began in April 2019 and is funded with State Transit Assistance Funds (STAF) has been and remains a popular mode of transportation for the older adult community (Attachment A). Recently, STA staff has received requests from transit dependent program participants asking to use the service to make essential trips, such as the pharmacy.

The Intercity Taxi Card program serves Americans with Disabilities Act (ADA) eligible County residents, regardless of age, by providing taxi rides within Solano County. The rides are subsidized with riders paying 20% or 40% as with the GoGo Program. Recently, STA's Solano Mobility staff has received complaints from program participants about the lack of availability of taxis and have been told that since COVID-19, some taxi drivers are preferring not to drive. This leaves an already vulnerable population even more so by not providing them access to essential services.

Solano County will be augmenting the STA Mobility Programs with \$150,000 in Coronavirus Aid, Relief, and Economic Security (CARES) Act Funding to help provide assistance to this vulnerable population.

#### **Discussion:**

STA staff recommended a pilot program, which was presented to and approved by the STA Board on September 9, 2020, expanding the Medical Trip Concierge (GoGo) Program to include the following:

- Include participation of ADA eligible Solano County residents; and
- Increase the number of rides per person per month to 20 (pre-pandemic limit was 10).

ADA eligible individuals are currently eligible for the subsidized Taxi Card program. The expansion will provide those ambulatory residents access to additional rides to medical trips, including pharmacies, that are currently being limited due to taxi availability. It is estimated, based on current usage of both programs, that the number of rides will increase considerably (Attachment B). While the CARES Act Funding requires funds to be expended by December 31, 2020, if the pilot is successful, STA will seek to fund the program with current STAF funds.

#### **Fiscal Impact:**

Program expansion would be funded using CARES Act Funds in the amount of \$150,000 that will be added to the STA Budget.

The *estimates* for the CARES fund spending (STA Cost) are based on the following:

- August no difference no expansion
- September increase based on adding GoGo users. If 40 registrants used 20 rides per month, that would equal 800 rides. If just half of the 79 PEX card users also began using GoGo, it would also add 800 more rides. Between current GoGo users and the projected PEX card users, there could be 1600 rides per month
- October December adding more users based on word of mouth, specifically to the ADA community.
