**Funding Recommendations** 

#### **Background:**

Transportation Development Act (TDA) funds are generated from a ¼ cent tax on retail sales throughout California. Two percent of the TDA funding generated is returned to each county in which it was generated in the form of TDA Article 3 (TDA-3) funds for bicycle and pedestrian projects. STA works with the Metropolitan Transportation Commission (MTC) to administer the TDA funds. MTC typically provides fund estimates each February, July, and October/November.

The Solano Transportation Authority (STA) works with member agency staff each spring to fund bicycle and pedestrian projects for the upcoming fiscal year, based on MTC's fund estimates. TDA-3 funding requests are reviewed by the Bicycle Advisory Committee (BAC), and the Pedestrian Advisory Committee (PAC). Recommendations are sent to the Technical Advisory Committee (TAC) and ultimately approved by the STA Board of Directors. Funds must be spent within three fiscal years.

#### **Discussion:**

Over the last two years, STA has conducted outreach to its member agencies to determine each entities priority bike and pedestrian projects. This effort kicked off in light of recently adopted 2020 Active Transportation Plan. The goal of this outreach is to formulate a 5-year TDA-3 vision program that would align the goals of STA and its member agencies to create a transparent funding and implementation timeline. This program list is designed to be fluid in order to provide a level of confidence for project sponsors to anticipate future TDA Article 3 funding. It provides time for them to finish design, environmental documents, or obtain matching funds. Projects may advance or be pushed back in the 5-year list if they do not complete those tasks. Additionally, all projects within this 5 year plan are included in the 2020 Active Transportation Plan. The projects included in the 5-year program are considered by the BAC and PAC, but only projects included in year one are formally recommended for approval.

The TDA-3 FY 2021-22 preliminary fund estimate from MTC is \$431,683. Last year the STA BAC and PAC voted to allocate \$25,000 a year for 3 years for a countywide wayfinding sign pilot program. After factoring that expense from the total, there is \$406,683 for all other projects. As seen in Attachment A, STA received 5 project submittals, totaling \$922,094 in requested funding.

Since the call for projects closed in late March, STA has held internal conversations regarding the merits of each application. After careful consideration, STA staff finds that the submittals from Benicia, Solano County, Suisun City, and Vallejo to be equally strong proposals and would like to help realize each of these projects. Therefore, STA staff recommends pursuing an

egalitarian approach to splitting up the remaining \$406,683 of funds, with Benicia, Solano County, Suisun City, and Vallejo to each receive \$101,659.50 for their project.

After reviewing the City of Dixon's application, STA staff could clearly understand the merits of the project but was unable to recommend it for funding due to the fact that it is not included in the 2020 Solano Active Transportation Plan.

While the STA staff has shared its recommendation for funding to the BAC and PAC, the committees are free to allocate the \$406,683 of funds as they see fit. STA staff has invited each of the aforementioned project sponsors to the Joint BAC and PAC meeting to further explain the merits of their submittals. Following these presentations, both committees will deliberate, identify, and vote on the appropriation of funding.

Dear Mr. Rosenwald,

The City of Benicia is pleased to submit its application for Transportation Development Act (TDA) Article 3 Grant consideration.

#### Background

The City of Benicia has developed the Military West Pedestrian and Bicycle Infrastructure Improvements Project (Project) that will enhance pedestrian and bicycle safety on Military West between West 7<sup>th</sup> Street and West 2<sup>nd</sup> Street. Portions of this project are either in design, construction or have been recently awarded a grant. Kindly refer to Attachment A for a status of the Project.

#### Proposed Project for TDA Article Grant Funding

The proposed project for TDA Article 3 funding is titled "Military West Pedestrian and Bicycle Infrastructure Improvements Project Between West 5<sup>th</sup> Street and West 3<sup>rd</sup> Street" (Proposed Project). The scope of work is in compliance with MTC Resolution No. 4108 and includes:

- Constructing 950 linear feet of 5-foot-wide sidewalk on the north side of Military West between West 5<sup>th</sup> Street and West 3<sup>rd</sup> Street where there is missing sidewalk, see Attachment B.
- Construction of 200 linear feet of 5-foot-high retaining wall near West 5<sup>th</sup> Street to provide adequate space for the new sidewalk.

- Restripe the existing Class 2 Bike Lanes in both directions of Military West between West 5<sup>th</sup> Street and West 3<sup>rd</sup> Street.
- Restripe the centerline stripe of Military West between West 5<sup>th</sup> Street and West 3<sup>rd</sup> Street for compliance with the current California Manual of Uniform Traffic Control Devices.
- Miscellaneous storm drain improvements.

Additionally, the scope is in compliance with the Solano Transportation Authority's Active Transportation Plan. In particular, the project complies with the Bicycle Network and Sidewalk Gap Network, see Attachments B and C, respectively.

#### Cost Estimate of the Military West Pedestrian and Bicycle Infrastructure Improvement Project

The total cost of the Military West Pedestrian and Bicycle Infrastructure Improvement Project is approximately \$2M, see Attachment D. The City of Benicia has secured \$1.18M in funding so far and is requesting \$200,000 in TDA Article 3 funding to match its local funding of \$169,000 to design and construct the Proposed Project that would complete the Military West Pedestrian and Bicycle Infrastructure Improvement Project, see Attachment E.

#### **Schedule**

In consideration that portions of the Project are either in design, construction or have been recently awarded a grant (HSIP Cycle 10), the City intends to start design immediately upon notification of award and complete design and construction within twelve months. To exemplify the City has started design on the Military West 3<sup>rd</sup> Street HSIP Cycle 10 project, see Attachment D.

#### Compliance with MTC Resolution No. 4108

The City of Benicia reviewed MTC Resolution No. 4108 and confirms that its Proposed Project is in compliance with said resolution. Additionally, the City of Benicia reviewed the Proposed Project with its bicycle and pedestrian representatives on March 29, 2021 and received overwhelming support.

#### **Grant Request**

As shown in Attachment A, the City of Benicia has nearly completed its Project. To complete the Project would require \$369K to design and construct the remaining segment between West 5<sup>th</sup> and West 3<sup>rd</sup> streets.

The City formally requests \$200K in TDA Article 3 Grant funding to match the local funding of \$169K proposed in this application to design and construct the Proposed Project.

Please note, if awarded, the \$200K will match the total local fund of \$437,672 (22%) and grant funds of \$1,553,779, for a total of \$1,991,451, to complete the Military West Pedestrian and Bicycle Infrastructure Improvement Project





#### 2. Provide a detailed project description:

Benicia Road is a four-lane parkway through a disadvantaged community with aged sidewalks, ADA ramps and bus stops. It has significant pedestrian and bicycle traffic from the local businesses, surrounding neighborhoods, and the Curtola Bus Hub. This portion of Benicia Road was originally built as a four-lane parkway to service vehicle traffic into and out of Mare Island Naval Shipyard and became a freeway in 1959. The associated older sidewalks were built with narrowed interfaces and short utility pole clearances, and the needs of bicyclists and pedestrians were not a primary consideration. The freeway has since been relinquished back to Solano County's right of way, but the current configurations through this corridor create a high stress environment for bicyclists and pedestrians.

Solano County and the City of Vallejo just completed a collaborative sidewalk gap connection project that began in 2020, which facilitates pedestrian connections to Benicia Road. This continues the County's effort to invest in Smart Growth improvements for this Disadvantaged Community. Solano County needs to modernize the Benicia Road corridor as its next Smart Growth project for this area by incorporating a road diet and updating the transit stops and bike/ped streetscape. The neighborhoods and local school children have actively used the Benicia Road corridor, and the project's expansion into alternative modes improvements will meet theneeds of the communities' future active transportation needs.

In detail, the project will incorporate a vehicular road diet by removing two through vehicle lanes and reconfigure Benicia Road into a two-lane road with street parking, a reversible turn lane and 5-foot separated class II bike lanes. Additional traffic calming striping and pavement coloring is incorporated to create a low stress bicyclist experience. We will be replacing aged sidewalks and transit stops with enhanced width sidewalks, curbs, turnouts, and ADA ramps. There will be a new bus shelter installed along with a bus turnout in front of it. We will be moving the crosswalk on Benicia Road at Starr Avenue to help with school traffic and enhance safety for pedestrians in the crosswalk with a raised median. Rain gardens and other sustainable greenscape will be incorporated to improve the corridor architecture and long-term sustainability. Local pedestrians and cyclists will be able to enjoy a calmer roadway configuration, improved transit stops, unobstructed larger sidewalks and designated Class II bike lanes.

The variety of project improvements proposed were identified as needs by the local community, SolTrans, the Solano County Board of Supervisors, and agency engineers. Various contacts and connections were made with the local community over the last 5 years regarding the need for improvements along the corridor. The Homeacres Improvement Association met several times and requested sidewalk gap closures and improved lighting throughout the area for pedestrians, businesses and students. Local transit riders requested improvements through SolTrans for the transit stop locations. And Residents requested various Benicia Road frontage improvements through the Solano County Sheriffs Office as a recommendation to improve safety in the area. Solano County Supervisors have expressed the need for enhanced ADA access and county engineering staff have identified traffic safety enhancement alternatives from the crash/safety data of corridor intersections and crossings. This project is vital to residents as well as the variety of schools nearby whose students utilize the corridor for daily connections. As a road diet, this project will enhance safety by reducing collisions, improve speed limit compliance, decrease crash severity, and thus encourage pedestrian activity. Once completed, the surrounding Disadvantaged Community, living and working immediately along and adjacent to both sides of Benicia Road, will enjoy enhanced access to schools, local businesses, and the Curtola Bus Hub.

### 3. Provide the total cost of the project and list other secured funding sources and their amounts dedicated to it.

The total project costs \$3,500,000 to complete all proposed improvements for public safety and traffic calming purposes. Solano County is committed to the project moving forward using other secured funds such as SBl allocations and Road Fund revenues; however, the County is seeking additional funds to provide enhanced streetscape improvements, including colored pavements, enhanced signing and striping, and other traffic calming features.

### 4. Describe the project location and target population. Attach a detailed map of the project area or location of the target population area that this project will serve.

The Benicia Road Project is in the unincorporated Solano County, surrounded by the City of Vallejo, on the west side of interstate 80 between Beach Street and Lemon Avenue. It is currently identified as Disadvantaged Community Track #0609525110, with a population 3,271 (See Attached Maps).

### 5. Include a project schedule (including project milestones) and indicate estimated project completion date.

Solano County will begin all preliminary surveying and environmental review in April of 2021. Design plans could be completed by December of 2021 and advertised for construction bids. Construction would start in April of 2022 with an estimated completion date in July of 2022.

Benicia Road from Beach Street to Lincoln Road West is in the Solano Countywide Active Transportation Plan. The Plan was adopted in 2020 and provides guidance to Solano TransportationAuthority (STA) to improve active transportation conditions throughout Solano County. The Plan incorporates previous active transportation planning efforts along with Countywide Bicycle, Pedestrian, Safe Routes to School and Safe Routes to Transit Plans into one collaborative plan. It provides a list of priority projects and guidance which STA and local jurisdictions can use to help people of all ages and abilities feel comfortable walking and bicycling in Solano County. Benicia Road is ranked as a high priority project. It is listed as a safe route to transit, safe route to school, supports equity goals and is part of a bikeway gap closure in the area that leads to the Vallejo Casual Carpool Pickup and the Curtola Bus Hub.

- Demonstrate what elements or components the project includes to qualify it as a 'Smart Growth'project.
  - Smart Growth goals and improvements are key to promoting walkable communities, increasing public transit use, improving bicycle use, and lowering vehicles miles traveled and greenhouse gasemissions. The Benicia Road Complete Streets Project will directly facilitate Smart Growth by incorporating the following Smart Growth principles:
  - 1) Mixed Land Uses: The Benicia Road corridor has already incorporated mixed uses including retail, commercial, and residential land use, but needs transportation investments to improve active transportation for the area.
  - 2) Create Walkable Communities: The Project will provide a safer walkable neighborhood with the sidewalk expansions, traffic calming additions, and improves the corridor look and feel withsustainable enhancements including rain gardens in some sidewalk sections. The design will make walking and bicycling not only practical but safe and convenient to enjoy.
  - 3) Distinctive Sense of Place: The surrounding community has been investing and expanding the adjacent businesses and investing in the housing, but the community has been asking for similarinvestment in the transportation corridor.
  - 4) Provide a Variety of Local Transportation Choices: The Project will be improving and addingbus stops and shelters along this transit corridor to attract ridership, which is supported by SolTrans.
  - 5) Community & Stakeholder Collaboration in Project Development: Solano County has already been collaborating with the community and stakeholders, including the

Homeacres Improvement Association, SolTrans, Solano County Board of Supervisors, local residents and business owners, and City of Vallejo staff to develop project improvements that will benefit the community and other various stakeholders.

• Indicate estimated number of pedestrian users that the project will serve at any given time(include assumptions)

It is estimated from the us census that there are 119,252 people residing in Vallejo CA, 6.5% use public transportation 1.8% walk and only 1% bike to work. Using the census track #06095251100located around Benicia Road there is a population of 3271 people residing in the project location. Using the US Census data and the Track number data it is estimated that approximately 200 peopleuse public transportation, 39 walk and 12 bike to work.

There are approximately 244 students living in the subdivisions surrounding Benicia Road that attend either junior high or high school, with several in proximity to the project. It is estimated that 20% of these students walk, bike or use public transportation. On average that is 49 students that would use Benicia Road every day to attend school.

 Indicate how pedestrian project will provide access to transit, schools, shopping, or employment

Solano County just completed a collaborative sidewalk gap closure on Beach Street from Benicia Road to an existing path at Curtola Parkway that goes to the Curtola Bus Hub. The Hub provides transit services for regional SolTrans Transit routes 82 (Richmond and San Francisco), R (Fairfield and Richmond), and Y (Benicia and Walnut Creek) with access to the Bay Area Rapid Transit System, along with local SolTrans routes 3 and 8 that connect to the Downtown Vallejo Transit Center and the SF Bay Ferry. This project would provide a safer route to Beach Street and the existing path to the park & ride and regional bus stop. The reconfiguration of striping on Benicia Road would provide a safe route to school for children who attend Hogan Jr. High School and Grant Elementary School. It would connect people to recreational opportunities such as Wilson Park and Lake Dalwigk Park. Replacing sidewalks, upgrading crosswalks and installing a separated class II bike lane on Benicia Road would provide a safer route to the shopping and restaurants on the other side ofl-80 including Starbucks, McDonalds, various other restaurants, and two convenience stores.

The census track data tells us that approximately 200 people use public transportation, 39 walk and 12

bike to work. According to the Vallejo Community Based Transportation Plan 2019/2020 two significant issues were raised by the community 1) the lack of benches, shelters and other amenities at many bus stops and 2) the need for safer, improved sidewalks, filling in gaps, and safer pedestrian crossings. Based on public input and census data we are estimating the number of peopleusing public transportation, walking or biking to work would increase significantly. This project will improve safety and comfort for people walking and biking and will encourage increased active transportation along the corridor. Therefore, reducing the number of vehicle trips by as many as 65 vehicle trips daily, as well as lowered vehicle miles traveled







#### Dixon SR-113 Project Description

North 1<sup>st</sup> Street, better known as State Route 113, is a major thoroughfare directly through the Downtown area of the City of Dixon. Being in the Downtown area, North 1<sup>st</sup> Street sees a large amount of pedestrian traffic with there only being a single signal crossing. There are currently two additional crosswalks that cross North 1<sup>st</sup> Street in the downtown area, with neither of them being "High visibility" or having RRFBs.

In order to make the downtown area more safe for pedestrian traffic, we are proposing to have the two crosswalks at the B Street and C Street intersections be updated to the "Continental" style high-visibility crosswalks, as well as having four RRFBs installed. Two RRFBs will be installed at each crosswalk, with each crosswalk having a northbound and southbound RRFB.

#### A. STA Brochure Update

The Top 10 Bike Rides and Top 10 Walk and Hike brochures are important resources in highlighting recreational opportunities throughout Solano County. Additionally, these brochures serve as an effective marketing tool to increase local tourism to Solano County from nearby environs. As part of the BAC and PAC's 2021 overall work plan, an update to the Top Ten Bike Rides and Hikes Brochures was included as a task for the committee to consider.

In previous meetings, STA staff engaged BAC and PAC members in a discussion on the process of proceeding with the brochure update. Based on those discussions, STA staff is proposing a new approach that incorporates the feedback provided by both committees.

STA staff proposes for the brochure update process to focus on revisiting and revising the original brochures. The work will focus on assessing whether any changes need to be made to the current routes or new routes should be added to replace current ones. In addition, the Top 10 lists will be expanded to a Top 20 to provide more options to Solano residents and tourists and showcase more of Solano County's natural assets and active transportation infrastructure. While the paper-based brochure will only list the Top 10, the electronic version that will be housed on the STA website and the future trail app technology that STA will utilize will feature the expanded Top 20 list.

Consistent with the past approach taken when the original brochures were developed, the BAC will take the lead for the Top 10 Bike Rides Brochure and the PAC will take the lead for Top 10 Walks and Hikes brochure. A special sub-committee will be created within the BAC and the PAC that will be tasked with the vetting process of the proposed routes for inclusion within both sets of brochures. Along with the recommendations provided by the citizen advisory committees, STA staff will conduct public outreach to local partners and Solano residents, through various outreach strategies that includes social media, to compile potential routes and locations for the special subcommittee to consider.

STA staff would like to continue discussions with the BAC and the PAC at the Special Meeting to finalize the process for the brochure update.
