2. APPROVAL OF AGENDA

3. OPPORTUNITY FOR PUBLIC COMMENT None

4. COMMENTS FROM STAFF AND REPRESENTATIVES FROM ADVISORY COMMITTEES ➤ Safe Route to School Plan Update

Amy Antunano announced RFQ was released with a due date of March 6th, should finalize on a consultant by April. Chair Owens volunteered to be a part of the review panelist. Budget allocation for SR2S Plan update is 250K.

> 2023 City of Fairfield Walk Audit: Middle and High Schools

Tina Tran summarized the City of Fairfield's Three E's committee: Education, Enforcement, and Engineering. Alternating between elementary and middle/high schools, the city staff walk the sites and find improvements to be completed by the next school year. 2022 had over 14 school improvements. This year the focus has been on Education for Rodriguez high school parents to direct pick up and drop off at the back of the school to alleviate traffic on Redtop Rd. Concerns on new jaywalking laws were raised, Mr. Guerrero will bring forth a presentation for the future agenda item.

> OBAG3 Safe Routes to School Project Update

Kathrina Gregana provided an overview of MTC's final awards for OBAG3. Seven out of 10 projects STA nominated were awarded, totaling 11.9 million countywide. SR2S-AC endorsed 4 projects, 3 were fully funded. Vacaville's Kairos SR2S project was not awarded, Staff is working with sponsor to draft a funding plan to deliver project.

5. PRESENTATION

A. Outerspacial Update

Dail Montanez presented on the collaboration of Outerspacial App and how to explore Solano County outdoors. Solano Land Trust is the primary license holder with sub licenses partnerships across the county. Ms. Montanez highlighted the Outerspatial App Challenge to kick off launch for the first year for participants to download. She continued to provide examples on how to find articles, trails, challenges, and announcements sharing the QR code for members to scan and share. Currently Heart Health Month and Heritage Park is hosting an event on Saturday, February 25^{th.}

B. 2023 Bay Area Bike Month

Amy Antunano indicated May is Bike Month, a regional effort to encourage families, commuters, and communities to bike everywhere. Bike to Work Day will be held on May 18, with energizer stations to check in throughout Solano County providing water and snacks. Staff will be organizing community bike rides and using OuterSpatial for promotional uses. Bike to School is May 3rd staff has started to collect registration forms for schools to participate and will receive swag for participants. **Ms. Antunano will be forwarding the list of events once finalized for Bike Month.** David Belef announced efforts on collaborating with librarians to promote bicycle books for the month.

8. ACTION ITEMS NON-FINANCIAL ITEMS

A. Comprehensive Transportation Plan (CTP) Update

Robert Guerrero indicated STA has established ad-hoc policy subcommittees for each of the CTP elements 1. Active Transportation 2. Arterials, Highways, and Freeways, 3. Transit and Rideshare and Working Group Chapters on Transportation and Land Use and Transportation Equity. The last CTP update was in 2020, this update serves STA as the primary long range planning document that prioritizes STA's investments. Any project or program seeking STA support must be identified in the STA's CTP to be considered for discretionary funds. Mr. Guerrero outlined the list of

participants to be included in ad-hoc committees and is seeking volunteers from SR2S-AC to participate. Staff are anticipating committees to meet 3 to 4 times before completion of plan provided timeframe between Spring 2023- Summer of 2024 and budget of 450K for these efforts. Meetings will be held the 2nd Wednesdays of the month before STA's Board Meetings.

David Belef volunteered as a possibility since work schedule is subject to change.

Recommendation :

Appoint Safe Routes to School Advisory Committee Representative to participate on the Comprehensive Transportation Plan's Alternative Modes Element Committee.

No motion was made. Mr. Guerrero asked for any other participants to please contact staff if interested.

9. INFORMATIONAL ITEMS

A. MTC Safe and Seamless Mobility Quick Strike

Amy Antunano announced STA received 600K in Quick Strike Funds. She continued to list where these funds will be allocated to with some going to the SR2S Plan Update, SR2S Enforcement Grant, and Young Engagement Program. Ms. Antunano will provide more information on the Enforcement Grant at the next meeting in May. The Youth Engagement Program is currently in a pilot phase with Fairfield High School, within the next year a robust program will be developed to engage both middle and high schoolers to teach bike and ped safety.

B. Solano SR2S Office of Traffic (OTS) Safety Grant Submittal

Amy Antunano indicated STA submitted application for OTS grant of 150K. If awarded, staff plans to put these funds towards Encouragement and Education. These funds will go towards crossing guard resources and bike rodeo safety events.

C. Program Coordinator Updates School Engagements

• Benicia/Vallejo

Jennifer Hanley announced newly engaged schools to join the "WOW" (walk or wheel) program launching on March 1st. City of Benicia recently lost a pedestrian bridge were Mary Farmer students planned on utilizing their walking school bus, currently on hold, city staff has provided safety measure efforts to accommodate and possibly provide a temporary bridge. She concluded her efforts in extending the Bay Area Bike Mobile Virtual Assemblies that are very engaging with students to 3 schools and 10 classes in Benicia and Vallejo. Safe Moves update is scheduled for a future agenda item.

• Fairfield-Suisun/Dixon

Ms. Antunano on behalf of Janelle Gregorio highlighted coordination with Nelda Mundy and Dover Academy to schedule a community Bike Rodeo inviting different schools to participate. Bike Rodeo is schedule in Dixon on April 14th Janelle Gregorio attended Fairfield Suisun Unified School District (FSUSD) discussing Suisun City Schools and Implementing Walking School Busses to address congestions.

• Rio Vista/Travis/Vacaville

Suzanne Antone stated her participation in the Kairos WoW Wednesday event with 60 students participating. She's been working on organizing Bike Rodeos with one scheduled for March 30th at DHY in Rio Vista. Ms. Antone will be tabling at Ag & Art festival on Earth Day Saturday, April 22 at Andrew's Park in Vacaville. She will also be promoting SR2S at the Vacaville's Public Education Foundation 20th annual Loop around the Lagoon on May 6th at Lagoon Valley Park.

10. COMMITTEE ROUNDTABLE AND FUTURE AGENDA TOPICS.

David Belef announced BAC welcomed a new member from the City of Suisun, Tyler Meirose and announced other vacancies still open for participants to join. Mr. Belef will be applying 4 participatory budget proposals to the City of Vallejo regarding Bicycle safety and education.

Karin Bloesch announced YSAQMD is launching the Clean Air Funds Grant on March 13 and close on April 21st for the cities of Vacaville, Rio Vista, and Dixon.

Background:

The Solano Safe Routes to School (SR2S) Program works to increase the number of students walking and bicycling to school by helping to make the journey safe, fun and healthy. Using a comprehensive approach, the program includes 6 "E's": education, encouragement, enforcement, engagement, engineering and evaluation. The program is available to all schools countywide and focuses on activities and programs that educate students on safety, health awareness and identifying improvements within communities countywide to enhance active student travel safety.

The Solano Safe Routes to School (SR2S) program supports a variety of engineering and enforcement strategies as part of its comprehensive approach. The main goal for SR2S enforcement strategies is to deter unsafe behaviors of drivers, pedestrians and bicyclists, and to encourage all road users to obey traffic laws and share the road safely. Enforcement is one of the complementary strategies that SR2S programs use to enable more children to walk and bicycle to school safely. The SR2S Program has been allocating \$150,000 in a 2-year grant cycle (using Congestion Mitigation and Air Quality Program funds (CMAQ) since the grant program's inception in 2011.

Discussion:

In preparation for the upcoming grant cycle (FYs 2023-25) STA SR2S staff will reach out to local law enforcement agencies to gauge interest in this grant opportunity. In past cycles all agencies were in support of the grant program, however many of the larger agencies expressed that the funds weren't enough to quantify the appropriate support needed to apply.

Staff are requesting the Safe Routes to School Advisory Committee review and approve the updated Scope of Work for the Public Safety and Education Enforcement Grant Cycle 6.

Fiscal Impact:

None. Funding for the SR2S Plan Update is included in the STA 2023-24 budget.

Approve recommended Scope of work for the Public Safety and Education Enforcement Grant Cycle 6.
