INTRODUCTION

The Solano Transportation Authority (STA) is a Joint Powers Authority comprised of members including the cities of Benicia, Dixon, Fairfield, Rio Vista, Suisun City, Vacaville, and Vallejo, and the County of Solano. The STA's mission is to improve the quality of life in Solano County by delivering transportation projects to ensure mobility, travel safety, and economic vitality for all. The STA uses an open and inclusive public involvement process through various committees made up of local elected officials, public works directors, transit operators, and interested citizens.

The STA serves as the Congestion Management Agency (CMA) for Solano County and is responsible for countywide transportation planning and programming of State and Federal funding for transportation projects within the county. As the CMA for Solano County, the STA is responsible for assisting local jurisdictions in attaining their transportation goals. A large aspect of reaching these goals comes from providing a safe travel experience to all modes of transportation within Solano County.

BACKGROUND

The Solano Transportation Authority (STA), as the Congestion Management Agency (CMA) for Solano County, is responsible for maintaining and implementing the Solano County Congestion Management Program (CMP). The CMP is a planning tool used to monitor and mitigate congestion on state-owned roadways as well as local arterials with the ultimate goal of lessening congestion or avoiding it together. As the CMA for Solano County, STA is required to update the CMP biannually on odd years, with information assessing how the CMP network is performing based on updated Capital Improvement Program (CIP) information, traffic counts and transit data. The last CMP update was completed in 2021 and can be reviewed directly on the STA's website from the following link: [2021 Solano County Congestion Management Program](#).

STA intends to retain the Consultant under contract through the end of 2023 to ensure all tasks are completed. Solano Transportation Authority (STA) has the discretion to extend the contract with the same consultant chosen for the 2023 CMP update to include future CMP update cycles scheduled for 2025 and 2027.

Components to the report should include:

- Definition of the CMP system
- Establishment of level of service standards
- CMP System Performance
- Multi-Modal System Performance
- Transportation Demand Management
- Travel Forecast Model
- A program for analyzing the impacts of land use decisions; and
- A seven-year Capital Improvement Program (CIP)

FINAL PRODUCT

The final product will be the 2023 version of the Solano County Congestion Management Program, along with all required elements as defined in the scope of work below.

DISADVANTAGED BUSINESS ENTERPRISE (DBE) GOAL

The STA has adopted a DBE goal that encourages the hiring of registered disadvantaged businesses, which can be found at <https://sta.ca.gov/work-with-sta/procurement-opportunities/>. This Project utilizes federal funds; the anticipated participation goal for DBE firms for the Project is 19%. Participation by DBE consultants or sub-consultants shall be in accordance with information contained in the Consultant Proposal DBE Commitment (Exhibit 10-O1), or in the Consultant Contract DBE Information (Exhibit 10-O2)

attached to and incorporated as part of this contract. If a DBE sub-consultant is unable to perform, the CONSULTANT must make a good-faith effort to replace him/her with another DBE sub-consultant, if the goal is not otherwise met.

SCOPE OF SERVICE TASKS

STA is seeking a consultant that can perform all of the necessary tasks to perform a complete update of the 2023 Solano County Congestion Management Program. The report should be consistent with California State Statute, California Department of Transportation (Caltrans) guidance, and the most recent [CMP guidance established in January 2023](#) by the Metropolitan Transportation Commission (MTC), as well as any future CMP guidance that may be issued during the course of this update. Interested consultants should review the [2021 Solano County Congestion Management Program](#) to ensure the new document is consistent with past findings. Consultant tasks are summarized into the following four tasks:

1. Project Management-Draft Monitoring Plan
2. Monitor and Analyze the Countywide Transportation Network
3. Prepare Monitoring Report
4. Development of the 2023 Congestion Management (CMP) Document

Task 1: Project Management-Draft Monitoring Plan

1.1 *Project Management*: Kick off meeting with STA and selected consultant to review project scope, negotiate final task budget and determine final timeline and schedule with milestone to complete the tasks.

1.2 *Prepare Draft Monitoring Plan*: In this subtask, the consultant will prepare a draft plan for collecting the auto travel data as identified in the Solano County CMP Network in **Attachment A** to this document. The draft monitoring plan will outline: 1) the methods employed to monitor the Countywide transportation network; 2) the designated routes in the Countywide transportation network on which those methods will be employed; and 3) the proposed schedule for monitoring and collecting/calculating the data.

1.3 *Prepare Final Monitoring Plan*: Based on comments made and direction received from STA staff, the consultant will prepare a final monitoring plan.

Task 2: Monitor and Analyze the Countywide Transportation Network

2.1 *Collect Data*: Consistent with the final monitoring plan, consultant will update and report on traffic and transit data for the entire CMP network (outlined in **Attachment A** to this document) in Solano County (in all cases, the traffic data should be less than 1-2 years old. STA staff will assist in obtaining traffic data):

- Interstates and State Routes (48 segments): Collect travel time runs and Average Daily Traffic (ADTs) (either from traditional traffic counts or data available from Caltrans or the City)
- Local Streets (12 segments): Collect travel time runs and ADTs (either from traditional traffic counts or data available from Caltrans or the City)
- Intersections (5 locations): Counts must include all turning movements, as well as bicycle and pedestrian counts
- Transit Data: Ridership data from SolanoExpress bus service, Capitol Corridor rail service, and San Francisco Bay Ferry service from Vallejo.
- HOV/Express Lane Data: Collect occupancy data
- Mode Choice Data

2.2 *Analyze and evaluate the Changes/Status of the Countywide Transportation Network from 2021 in Solano County*: Using the information collected in subtask 2.1, the consultant will calculate measures used in determining the CMP Level of Service (LOS) and other appropriate standards such as Vehicle Miles Traveled (VMT) to analyze the current status of each designated location. The analysis will be consistent with the methodologies identified in the final monitoring plan. If, as a result of this subtask, the consultant identifies segments that operate at a LOS that exceeds the adopted standard for that segment, the consultant will monitor and calculate those segments two more times. If two of the three calculations exceed the accepted standard, the consultant will prepare a memorandum reporting that finding.

Task 3: Prepare Monitoring Report

3.1 *Prepare Draft Monitoring Report*: The consultant will prepare a draft report on the status of the Countywide transportation network detailing the results of Task 2.

The report should at minimum follow the format identified below:

- Introduction
- Purpose of the Monitoring Program
- Description of the Monitoring Program: Include methodologies for collecting and analyzing data
- Monitoring Results: Prepare tables that outlines the current status of each location within the county and a separate table comparing each segment with historic data.
- Actions: Divide the study locations into different levels according to their status and recommend appropriate actions to maintain or improve each level. Include actions that are already being taken by different agencies to address problems.

3.2 *Prepare Final Monitoring Reports*: After meeting with STA staff to discuss the draft report, the consultant will finalize the monitoring report based on comments received.

Task 4: Development of the 2023 CMP Document

4.1 *Prepare the final CMP document:* Prepare the final CMP document, while ensuring consistency with California state statute and MTC’s guidance for Consistency of Congestion Management Programs with the Regional Transportation Plan (RTP). Note that MTC’s current adopted RTP is Plan Bay Area 2050 released in October 2021. The final CMP document will consist of the following:

- **Executive Summary or Highlights from the CMP**
- **Designated Roadway System:** Define the CMP system for Solano County.
- **CMP System Performance:** Define the Level of Service (LOS) standard for all CMP network roadways. Evaluate the CMP System Performance Measures, including Level of Service (LOS), Vehicle Miles Traveled (VMT), and Vehicle Hours Delayed for traffic congestion and travel time reliability. Utilize the data prepared in the Monitoring Report to report on the status of the Countywide transportation system.
- **Evaluate the switch from LOS metrics to VMT metrics and its impact to the CMP System Performance.**
- **Multi-Modal System Performance:** Use the results of the data collection to prepare this section. This section should include ridership and fare box recovery of the SolanoExpress bus service, as well as descriptions of other local and regional transit services. It should also include a summary of available bike and pedestrian facilities in Solano County.
- **Travel Demand Management:** Provide a summary and purpose of STA’s travel demand management services, including the Solano Mobility program.
- **Land Use Analysis:** Provide a summary and purpose of STA’s program to analyze the impacts of land use decisions made by local jurisdictions on the regional transportation system, including the use of mitigation, deficiency plans and its connection to Vehicle Miles Traveled (VMT).
- **Travel Forecast Model:** Provide a summary and purpose of the Solano Activity Based Model, and the role it plays in monitoring future congestion on Solano County’s roadways.
- **Update the CMP 7 year Capital Improvement Program (CIP), and Transportation Demand Management (TDM) program.**
- Include appendices with technical documentation, as appropriate.

4.2 *Finalize CMP Document & Board Presentation:* Consultant should finalize CMP document after receiving STA staff comments, member agency staff comments, STA Board comments, and public comments. Consultant staff should also be available to present the final CMP document to the STA Board, if needed.

INSTRUCTION TO PROPOSER

1. *Examination of Proposal Documents:* By submitting a proposal, the proposer represents that they have thoroughly examined and become familiar with the work required under this RFQ, and that they are capable of performing the work identified in the Scope of Work.
2. *Addenda/Clarifications:* Explanations or clarifications desired by respondents regarding the meaning or interpretation of the RFQ may be requested verbally or in writing. All inquiries pertaining to this RFQ should be emailed to **Dulce Jimenez**, Planning Assistant, at the following email address: **djimenez@sta.ca.gov** no later than 4:00 PM (local), **March 17 2023**. Response to all questions submitted by the **March 17, 2023** deadline that may have a material impact on the proposal will be posted on the STA website at www.sta.ca.gov by **March 21, 2023**.
3. *Withdrawal of Proposal Submittal:* A proposer may withdraw its proposal at any time before the expiration of the time for submission of proposal submittals as provided in this RFQ by delivering to the procurement officer a written request for withdrawal signed by, or on behalf of, the proposer.
4. *Rights of STA:* This RFQ does not commit STA to enter into a contract, nor does it obligate STA to pay for any costs incurred in preparation and submission of the proposal or in anticipation of a contract.

STA may investigate the qualifications of any proposer under consideration, require confirmation of information furnished by the proposer, and require additional evidence or qualifications to perform the services described in this RFQ.

STA, in its sole discretion, reserves the right to:

- Reject any or all proposal submittals.
- Issue one or more subsequent RFQs and/or RFPs.
- Postpone opening for its own convenience.
- Remedy technical errors in the RFQ and/or RFP process.
- Approve or disapprove the use of particular subcontractors.
- Negotiate with any, all, or none of the proposers responding to this RFQ.
- Solicit best and final offers from all or some of the proposers.
- Award a contract to one or more proposers.
- Waive informalities and irregularities in any proposal.

5. *Contract Type:*

Proposers shall be prepared to accept the terms and conditions of STA's standard form contract included as **ATTACHMENT B** (STA Sample Professional Service Agreement) hereto. If a proposer desires to take exception to the agreement, the proposer shall provide the following information as a section of the proposal identified as "Exceptions to the Agreement":

- a. Proposer shall clearly identify each proposed change to the agreement, including all relevant exhibits and attachments.
- b. Proposer shall furnish the reasons therefore as well as specific recommendations for alternative language.

The above factors will be taken into account in evaluating proposals. Substantial exceptions to the agreement may be determined by STA, at its sole discretion, to be unacceptable and STA may proceed with negotiations with the other proposed firms.

RFQ SUBMITTAL REQUIREMENTS

Please prepare your qualifications in accordance with the following requirements.

1. *Qualifications:* The qualifications (excluding resumes and the transmittal letter) shall not exceed a total of 10 single-sided, 8.5" x 11" pages. Include in the appendix similar examples of past projects.
2. *Transmittal Letter:* The qualifications shall be transmitted with a cover letter describing the firm's/team's interest and commitment to the proposed project. The letter shall state that the qualifications shall be valid for a 90-day period and should include the name, title, address, and telephone number of the individual to whom correspondence and other contacts should be directed during the consultant selection process. The person authorized by the firm/team to negotiate a contract with STA shall sign the cover letter.

3. *Project Understanding:* This section shall clearly convey that the consultant understands the nature of the work and issues related to the development of the Solano Countywide Local Road Safety Plan.
4. *Approach and Management Plan:* This section shall provide the firm's/team's proposed approach and management plan for providing the services. Include an organization chart showing the proposed relationships among consultant staff, STA staff and any other parties that may have a significant role in the delivery of this project.
5. *Qualifications and Experience:* The qualifications submittal shall provide the qualifications and experience of the consultant team that will be available for the development of the Solano County Congestion Management Program (CMP) 2023 Update. Emphasize the specific qualifications and experience from projects similar to this project for the Key Team Members. Key Team Members are expected to be committed for the duration of the project. Replacement of Key Team Members will not be permitted without prior consultation with and approval of the STA.
6. *Staffing Plan:* The qualifications shall provide a staffing plan required to complete the time for the Solano County Congestion Management Program (CMP) 2023 Update. Discuss the workload—both current and anticipated—for all Key Team Members, and their capacity to perform the requested services for the development of a Solano County Congestion Management Program (CMP) 2023 Update according to your proposed schedule. Discuss the firm/team's approach for completing the requested services for this project within budget.
7. *Work Plan and Schedule:* This section shall include a description and schedule of how each task deliverable of the project will be completed. The Work Plan should be in sufficient detail to demonstrate a clear understanding of the project. The schedule should show the expected sequence of tasks and include durations for the performance of each task, milestones, submittal dates and review periods for each submittal. Discuss the firm/team's approach for completing the requested services for this project on schedule. **The project is expected to commence no later than by June 1, 2023, with the Final CMP Document to be completed by October 1, 2023.**

8. *Cost Control:* Provide information on how the firm/team will control project costs to ensure all work is completed within the negotiated budget for the project. Include the name and title of the individual responsible for cost control.
9. *Additional Relevant Information:* Provide additional relevant information that may be helpful in the selection process (not to exceed the equivalent of 2 single-sided pages).
10. *References:* For each Key Team Member, provide at least three references (names and current phone numbers) from recent work (previous three years). Include a brief description of each project associated with the reference and the role of the respective team member.
11. *Submittal of Proposal:* Four (4) hard copies and one (1) digital copy (via flash drive) of your proposal are due at the STA office **no later than 4:00 p.m., March 27, 2023**. Envelopes or packages containing the proposal should be clearly marked, **“Solano County Congested Congestion Management Program (CMP) 2023 Update.”**
12. *Cost Proposal:* A cost proposal should be submitted in a **separate sealed envelope titled “CMP 2023 Update BUDGET.”** The budget should indicate the number of anticipated hours by the Project Manager and Key Team Members. The estimated level of hours for other staff can be summarized in general categories. The submitted cost proposal must be in an appropriate format. See Exhibit 10-H (attached) for sample structure, though it need not be identical.

SELECTION OF CONSULTANT & CRITERIA

The overall process will be to evaluate the technical components of all qualifications completely and independently from the cost component. The qualifications will be evaluated and scored of a 100-point total basis using the following criteria:

1. Project understanding and approach (25 points)
2. Business presence and/or experience in Solano County (25 points)
3. Qualifications and specific experience of Project Manager and personnel (25 points)
4. Experience with similar types of projects (15 points)
5. Satisfaction of previous clients (10 points)

The overall process will be to evaluate the proposals and experience with similar types of efforts, plans, and studies. If interviews are deemed appropriate, at STA’s discretion selected firms/consultants may be invited for an interview sometime between the weeks of April 3- April 14. The Project Manager and Key Team Members should attend the interview. The evaluation interview panel may include representatives from STA and other agencies, but the specific composition of the panel will not be revealed prior to the interviews. Costs for travel expenses and qualification preparation shall be borne by the consultants.

STA staff will provide the appropriate notice and schedule for interviews, with interviews scheduled to be held via zoom. STA staff will select the most qualified consultant or consultant team based primarily on experience, ability to contain costs and conducting very similar projects. Recent experience in Solano County is desirable.

Once the top firm/team has been selected, STA staff will negotiate a services contract with the selected firm/team. STA intends to retain the Consultant under contract through the end of 2023 to ensure all tasks are completed. Solano Transportation Authority (STA) has the discretion to extend the contract with the same consultant chosen for the 2023 CMP update to include future CMP update cycles scheduled for 2025 and 2027.

DISCLOSURE

The master copy of each response to this RFQ shall be retained for official files and will become a public record after the award of a contract unless the qualifications or specific parts of the qualifications can be shown to be exempt by law (Government Code section 6250 et seq.). Each Responding Firm may clearly label part of a submittal as "CONFIDENTIAL" if the Responding Firm agrees to indemnify and defend the STA for honoring such a designation. The failure to so label any information that is released by the STA shall constitute a complete waiver of all claims for damages caused by any release of the information. If a public records request for labeled information is received by the STA, the STA will notify the Responding Firm of the request and delay access to the material until seven working days after notification to the Responding Firm. Within that time delay, it will be the duty of the Responding Firm to act in protection of its labeled information. Failure to so act shall constitute a complete waiver.

PROTEST AND APPEALS

Any actual or prospective bidder, offer, or contractor who is aggrieved in connection with the Solicitations or Notice of Intent to Award a contract may protest to the Executive Director. The protest shall be submitted in writing to the Executive Director within seven (7) working days after such aggrieved person or company knows or should have known of the facts giving rise thereto. All letters of protest shall clearly identify the reasons for the protest. The protest also must state the law, rule, regulation, or policy upon which the protest is based. The Executive Director shall issue a written decision within ten (10) working days after receipt of the protest. The decision shall state the reason for the action taken; and inform the protester that a request of further administrative appeal of an adverse decision must be submitted in writing to the Clerk of the STA Board of Directors within seven (7) working days after receipt of the decision by the Executive Director.

State Routes






- D. CONSULTANT and the agents and employees of CONSULTANT, in the performance of this contract, shall act in an independent capacity and not as officers or employees or agents of STA.
- E. Without the prior written consent of STA, this contract is not assignable by CONSULTANT either in whole or in part.
- F. No alteration or variation of the terms of this contract shall be valid, unless made in writing and signed by the parties; and no oral understanding or agreement not incorporated in, shall be binding on any of the parties.
- G. The consideration to be paid to CONSULTANT under this contract shall be in compensation for all of CONSULTANT's expenses incurred in the performance of this contract, including travel and per diem, unless otherwise expressly so provided.

- C. Any costs for which payment has been made to CONSULTANT that are determined by subsequent audit to be unallowable under 49 CFR, Part 18 and 48 CFR, Federal Acquisition Regulations System, Chapter 1, Part 31.000 et seq., are subject to repayment by CONSULTANT to STA.
- D. All subcontracts in excess of \$25,000 shall contain the above provisions.

ARTICLE VIII RETENTION OF RECORDS/AUDIT

For the purpose of determining compliance with Public Contract Code section 10115, et seq. and Title 21, California Code of Regulations, Chapter 21, Section 2500 et seq., when applicable and other matters connected with the performance of the contract pursuant to Government Code section 8546.7; CONSULTANT, subconsultants, and STA shall maintain and make available for inspection all books, documents, papers, accounting records, and other evidence pertaining to the performance of the contract, including but not limited to, the costs of administering the contract. All parties shall make such materials available at their respective offices at all reasonable times during the contract period and for three years from the date of final payment under the contract. The state, State Auditor, STA, FHWA, or any duly authorized representative of the Federal Government shall have access to any books, records, and documents of CONSULTANT and its certified public accountants (CPA) work papers that are pertinent to the contract and indirect cost rates (ICR) for audit, examinations, excerpts, and transactions, and copies shall be furnished if requested. Subcontracts in excess of \$25,000 shall contain this provision.

ARTICLE IX AUDIT REVIEW PROCEDURES

- A. Any dispute concerning a question of fact arising under an interim or post audit of this contract that is not disposed of by agreement, shall be reviewed by STA'S Executive Director.
- B. Not later than 30 days after issuance of the final audit report, CONSULTANT may request a review by STA'S Executive Director of unresolved audit issues. The request for review will be submitted in writing.
- C. Neither the pendency of a dispute nor its consideration by STA will excuse CONSULTANT from full and timely performance, in accordance with the terms of this contract.

- D. If selected for audit or review, the contract, cost proposal and ICR and related work papers, if applicable, will be reviewed to verify compliance with 48 CFR, Part 31 and other related laws and regulations. ensure federal, state, or local government officials are allowed full access to the CPA's work papers including making copies as necessary. The contract, cost proposal, and ICR shall be adjusted by CONSULTANT and approved by STA contract manager to conform to the audit or review recommendations. CONSULTANT agrees that individual terms of costs identified in the audit report shall be incorporated into the contract by this reference if directed by STA at its sole discretion. Refusal by CONSULTANT to incorporate audit or review recommendations, or to ensure that the federal, state or local governments have access to CPA work papers, will be considered a breach of contract terms and cause for termination of the contract and disallowance of prior reimbursed costs.

- E. CONSULTANT Cost Proposal is subject to a CPA ICR Audit Work Paper Review by Caltrans' Audit and Investigation (Caltrans). Caltrans, at its sole discretion, may review and/or audit and approve the CPA ICR documentation. The Cost Proposal shall be adjusted by the CONSULTANT and approved by the STA Contract Administrator to conform to the Work Paper Review recommendations included in the management letter or audit recommendations included in the audit report. Refusal by the CONSULTANT to incorporate the Work Paper Review recommendations included in the management letter or audit recommendations included in the audit report will be considered a breach of the contract terms and cause for termination of the contract and disallowance of prior reimbursed costs.
1. During a Caltrans' review of the ICR audit work papers created by the CONSULTANT's independent CPA, Caltrans will work with the CPA and/or CONSULTANT toward a resolution of issues that arise during the review. Each party agrees to use its best efforts to resolve any audit disputes in a timely manner. If Caltrans identifies significant issues during the review and is unable to issue a cognizant approval letter, STA will reimburse the CONSULTANT at a provisional ICR until a FAR compliant ICR {e.g. 48 CFR, part 31; GAGAS (Generally Accepted Auditing Standards); CAS (Cost Accounting Standards), if applicable; in accordance with procedures and guidelines of the American Association of State Highways and Transportation Officials Audit Guide; and other applicable procedures and guidelines} is received and approved by A&I. Provisional rates will be as follows:
 - a. If the proposed rate is less than 150% - the provisional rate reimbursed will be 90% of the proposed rate.
 - b. If the proposed rate is between 150% and 200% - the provisional rate will be 85% of the proposed rate.
 - c. If the proposed rate is greater than 200% - the provisional rate will be 75% of the proposed rate.
 2. If Caltrans is unable to issue a cognizant letter per paragraph E.1. above, Caltrans may require CONSULTANT to submit a revised independent CPA-audited ICR and audit report within three (3) months of the effective date of the management letter. CONSULTANT may submit to STA final invoice only when all of the following items have occurred: (1) Caltrans approves or rejects the original or revised independent CPA-audited ICR; (2) all work under this contract has been completed to the satisfaction of LOCAL GAENCY; and, (3) Caltrans has issued its final ICR review letter. The CONSULTANT MUST SUBMIT ITS FINAL INVOICETO local agency no later than 60 days after occurrence of the last of these items.

The provisional ICR will apply to this contract and all other contracts executed between STA and the CONSULTANT, either as a prime or subconsultant, with the same fiscal period ICR.

ARTICLE X SUBCONTRACTING

- A. Nothing contained in this contract or otherwise, shall create any contractual relation between STA and any subconsultant(s), and no subcontract shall relieve CONSULTANT of its responsibilities and obligations hereunder. CONSULTANT agrees to be as fully responsible to STA for the acts and omissions of its subconsultant(s) and of persons either directly or indirectly employed by any of them as it is for the acts and omissions of persons directly employed by CONSULTANT. CONSULTANT's obligation to pay its subconsultant(s) is an independent obligation from STA'S obligation to make payments to the CONSULTANT.
- B. CONSULTANT shall perform the work contemplated with resources available within its own organization and no portion of the work pertinent to this contract shall be subcontracted without written authorization by STA's Contract Administrator, except that, which is expressly identified in the approved Cost Proposal.
- C. CONSULTANT shall pay its subconsultants within ten (10) calendar days from receipt of each payment made to CONSULTANT by STA.
- D. Any subcontract in excess of \$25,000 entered into as a result of this contract shall contain all the provisions stipulated in this contract to be applicable to subconsultants.
- E. Any substitution of subconsultant(s) must be approved in writing by STA's Contract Administrator prior to the start of work by the subconsultant(s).

ARTICLE XI EQUIPMENT PURCHASE

- A. Prior authorization in writing, by STA's Contract Administrator shall be required before CONSULTANT enters into any unbudgeted purchase order, or subcontract exceeding \$5,000 for supplies, equipment, or CONSULTANT services. CONSULTANT shall provide an evaluation of the necessity or desirability of incurring such costs.
- B. For purchase of any item, service or consulting work not covered in CONSULTANT's Cost Proposal and exceeding \$5,000 prior authorization by STA's Contract Administrator; three competitive quotations must be submitted with the request, or the absence of bidding must be adequately justified.
- C. Any equipment purchased as a result of this contract is subject to the following: "CONSULTANT shall maintain an inventory of all nonexpendable property. Nonexpendable property is defined as having a useful life of at least two years and an acquisition cost of \$5,000 or more. If the purchased equipment needs replacement and is sold or traded in, STA shall receive a proper refund or credit at the conclusion of the contract, or if the contract is terminated, CONSULTANT may either keep the equipment and credit STA in an amount equal to its fair market value, or sell such equipment at the best price obtainable at a public or private sale, in accordance with established STA procedures; and credit STA in an amount equal to the sales price. If CONSULTANT elects to keep the equipment, fair market value shall be determined at CONSULTANT's expense, on the basis of a competent independent appraisal of such equipment. Appraisals shall be obtained from an appraiser mutually agreeable to by STA and CONSULTANT, if it is determined to sell the equipment, the terms and conditions of such sale must be approved in advance by STA." 49 CFR, Part 18 requires a credit to Federal funds when participating equipment with a fair market value greater than \$5,000 is credited to the project.
- D. All subcontracts in excess \$25,000 shall contain the above provisions.

For breach or violation of this warranty, STA shall have the right in its discretion; to terminate the contract without liability; to pay only for the value of the work actually performed; or to deduct from the contract price; or otherwise recover the full amount of such rebate, kickback or other unlawful consideration.

ARTICLE XV PROHIBITION OF EXPENDING STA STATE OR FEDERAL FUNDS FOR LOBBYING

Any person who fails to file the required certification shall be subject to a civil penalty of not less than \$10,000 and not more than \$100,000 for each such failure.
- C. CONSULTANT also agrees by signing this document that he or she shall require that the language of this certification be included in all lower-tier subcontracts, which exceed \$100,000 and that all such sub recipients shall certify and disclose accordingly.

CONSULTANT's signature affixed below shall constitute a certification under penalty of perjury under the laws of the State of California, that CONSULTANT has complied with Title 2 CFR, Part 180, "OMB Guidelines to Agencies on Government wide Debarment and Suspension (nonprocurement)", which certifies that he/she or any person associated therewith in the capacity of owner, partner, director, officer, or manager, is not currently under suspension, debarment, voluntary exclusion, or determination of ineligibility by any federal agency; has not been suspended, debarred, voluntarily excluded, or determined ineligible by any federal agency within the past three (3) years; does not have a proposed debarment pending; and has not been indicted, convicted, or had a civil judgment rendered against it by a court of competent jurisdiction in any matter involving fraud or official misconduct within the past three (3) years. Any exceptions to this certification must be disclosed to STA.

- B. This contract is valid and enforceable only, if sufficient funds are made available to STA for the purpose of this contract. In addition, this contract is subject to any additional restrictions, limitations, conditions, or any statute enacted by the Congress, State Legislature, or STA governing board that may affect the provisions, terms, or funding of this contract in any manner.
- C. It is mutually agreed that if sufficient funds are not appropriated, this contract may be amended to reflect any reduction in funds.
- D. STA has the option to void the contract under the 30-day termination clause pursuant to Article VI, or by mutual agreement to amend the contract to reflect any reduction of funds.

ARTICLE XIX CHANGE IN TERMS

- A. This contract may be amended or modified only by mutual written agreement of the parties.
- B. CONSULTANT shall only commence work covered by an amendment after the amendment is executed and notification to proceed has been provided by STA's Contract Administrator.
- C. There shall be no change in CONSULTANT's Project Manager or members of the project team, as listed in the approved Cost Proposal, which is a part of this contract without prior written approval by STA's Contract Administrator.

Failure by CONSULTANT to carry out these requirements is a material breach of this contract, which may result in the termination of this contract or such other remedy as STA deems appropriate.

- G. - K. If a DBE subconsultant is decertified during the life of the contract, the decertified subconsultant shall notify CONSULTANT in writing with the date of decertification. If a subconsultant becomes a certified DBE during the life of the Contract, the subconsultant shall notify CONSULTANT in writing with the date of certification. Any changes should be reported to STA's Contract Administrator within 30 days.

ARTICLE XXI CONTINGENT FEE

CONSULTANT warrants, by execution of this contract that no person or selling agency has been employed, or retained, to solicit or secure this contract upon an agreement or understanding, for a commission, percentage, brokerage, or contingent fee, excepting bona fide employees, or bona fide established commercial or selling agencies maintained by CONSULTANT for the purpose of securing business. For breach or violation of this warranty, STA has the right to annul this contract without liability; pay only for the value of the work actually performed, or in its discretion to deduct from the contract price or consideration, or otherwise recover the full amount of such commission, percentage, brokerage, or contingent fee.

ARTICLE XXII DISPUTES

- A. CONSULTANT shall comply with OSHA regulations applicable to CONSULTANT regarding necessary safety equipment or procedures. CONSULTANT shall comply with safety instructions issued by STA Safety Officer and other STA representatives. CONSULTANT personnel shall wear hard hats and safety vests at all times while working on the construction project site.
- B. Pursuant to the authority contained in Section 591 of the Vehicle Code, STA has determined that such areas are within the limits of the project and are open to public traffic. ARTICLE XXV INSURANCE AND INDEMNIFICATION

A. CONSULTANT shall procure and maintain for the duration of this Contract the following insurance:

Minimum Scope of Insurance:

Coverage shall be at least as broad as:

1. Insurance Services Office Commercial General Liability coverage ("occurrence" form CG 0001).
2. Insurance Services Office form number CA 0001 (Ed. 1/87) covering Automobile Liability, code 1 (any auto). If CONSULTANT owns no vehicles, this requirement may be satisfied by a non-owned auto endorsement to the general liability policy described above. If CONSULTANT or CONSULTANT's employees will use personal autos on this project, CONSULTANT shall obtain evidence of personal auto liability coverage for each person.
3. Workers' Compensation insurance as required by the State of California and Employer's Liability insurance.
4. Errors and Omissions liability insurance appropriate to the CONSULTANT's profession. Architect's and engineers' coverage is endorsed to include contractual liability.

Minimum Limits of Insurance:

CONTRACTOR shall maintain limits no less than:

1. General Liability: \$2,000,000 per occurrence for bodily injury, personal injury and property damage. If Commercial General Liability Insurance or other form with a general aggregate limit is used, either the general aggregate limit shall apply separately to this location or the general aggregate limit shall be twice the required occurrence limit.
2. Automobile Liability: \$2,000,000 per accident for bodily injury and property damage, combined single limit.
3. Employer's Liability: \$2,000,000 per accident for bodily injury or disease, and in the aggregate.
4. Errors and Omissions Liability: \$1,000,000 on a claims made basis.

Deductibles and Self-Insurance Retentions:

Any deductibles or self-insured retentions exceeding \$50,000 must be declared to and approved by the STA. At the option of STA, either: the CONSULTANT shall reduce or eliminate such deductibles or self-insured retentions regarding the STA, its officers, officials, employees and volunteers; or CONSULTANT shall provide a financial guarantee satisfactory to the STA guaranteeing payment of losses and related investigations, claim administration and defense expenses.

Other Insurance Provisions:

The general liability and automobile liability policies must contain, or be endorsed to contain, the following provisions:

1. The STA, its officers, officials, employees and volunteers be covered as insureds regarding the liability arising out of automobiles owned, leased, hired or borrowed by or for the CONSULTANT, and regarding liability arising out of work or operations by or for the CONSULTANT including materials, parts or equipment furnished with such work or operations.

All certificates and endorsements must be received and approved by the STA before work commences. STA reserves the right to require complete, certified copies of all required insurance policies, including endorsements effecting coverage required by these specifications.

B. CONSULTANT shall indemnify and hold harmless the STA, its officers, officials, employees and volunteers against all actions, causes of actions, damages, costs, liabilities, claims, losses, judgments, penalties and expenses of every type and description, including without limitation any fees and/or costs reasonably incurred by STA's staff attorneys or contract attorneys and any and all costs, fees and expenses incurred in enforcing this provision (collectively referred to as "liabilities"), arising out of or for any negligent act or omission, misconduct or other legal fault of CONSULTANT, its officers, employees, sub-contractors, subcontractors or agents in connection with the performance or nonperformance of this Contract, whether or not STA accepted or approved any service or work product performed or provided by CONSULTANT, and whether or not such liabilities are litigated, settled or reduced to judgment. If a final decision or judgment allocates liability by determining any portion of damages awarded is attributable to STA's negligence or willful misconduct, STA shall pay the portion of damages allocated to STA's negligence or willful misconduct, provided that STA shall not be liable for any passive negligence of STA, its officers, officials, employees and volunteers in reviewing, accepting or approving any service or work product performed or provided by CONSULTANT.

CONSULTANT shall, upon STA's request, defend with counsel approved by STA (which approval shall not be unreasonably withheld), at CONSULTANT's sole cost and expense, any action, claim, suit, cause of action

CONSULTANT is not liable for claims, liabilities, or losses arising out of, or connected with the modification, or misuse by STA of the machine-readable information and data provided by CONSULTANT under this contract; further, CONSULTANT is not liable for claims, liabilities, or losses arising out of, or connected with any use by STA of the project documentation on other projects for additions to this project, or for the completion of this project by others, except only such use as many be authorized in writing by CONSULTANT.
- D. Applicable patent rights provisions regarding rights to inventions shall be included in the contracts as appropriate (48 CFR 27, Subpart 27.3 - Patent Rights under Government Contracts for federal-aid contracts).
- E. STA may permit copyrighting reports or other agreement products. If copyrights are permitted; the agreement shall provide that the FHWA shall have the royalty-free nonexclusive and irrevocable right to reproduce, publish, or otherwise use; and to authorize others to use, the work for government purposes.
- F. Any subcontract in excess of \$25,000 entered into as a result of this contract, shall contain all of the provisions of this Article.
