## **DISCLOSURE**

The master copy of each response to this RFP shall be retained for official files and will become a public record after the award of a contract unless the qualifications or specific parts of the qualifications can be shown to be exempt by law (Government Code section 6250 et seq.). Each Responding Firm may clearly label part of a submittal as "CONFIDENTIAL" if the Responding Firm agrees to indemnify and defend the STA for honoring such a designation. The failure to so label any information that is released by the STA shall constitute a complete waiver of all claims for damages caused by any release of the information. If a public records request for labeled information is received by the STA, the STA will notify the Responding Firm of the request and delay access to the material until seven working days after notification to the Responding Firm. Within that time delay, it will be the duty of the Responding Firm to act in protection of its labeled information. Failure to so act shall constitute a complete waiver.

## **PROTEST AND APPEALS**

Any actual or prospective bidder, offeror, or contractor who is aggrieved in connection with the Solicitations or Notice of Intent to Award a contract may protest to the Executive Director. The protest shall be submitted in writing to the Executive Director within seven (7) working days after such aggrieved person or company knows or should have known of the facts giving rise thereto. All letters of protest shall clearly identify the reasons for the protest. The protest also must state the law, rule, regulation, or policy upon which the protest is based. The Executive Director shall issue a written decision within ten (10) working days after receipt of the protest. The decision shall; state the reason for the action taken; and inform the protester that a request of further administrative appeal of an adverse decision must be submitted in writing to the Clerk of the STA Board of Directors within seven (7) working days after receipt of the decision by the Executive Director.

## **INTRODUCTION**

The Solano Transportation Authority (STA) is a Joint Powers Authority comprised of members including the cities of Benicia, Dixon, Fairfield, Rio Vista, Suisun City, Vacaville, and Vallejo, and the County of Solano. The STA serves as the Bay Area County Transportation Agency (BACTA) for Solano County and is responsible for coordinating countywide transportation plans, programs, and projects under a Joint Powers Authority among the Cities and County of Solano.

The Solano Economic Development Corporation (Solano EDC) is a public-private, nonprofit, dedicated to the economic growth of Solano County – scaling local traded sector industries, attracting new jobs and investment and maintaining competitive advantages for both existing and new businesses. The STA partners with Solano EDC on a variety of initiatives and projects to advance economic development in Solano County.

## **BACKGROUND**

The 2018 California State Rail Plan, the state’s strategic plan for creating a coordinated, statewide rail network, identified a “Solano County Hub” to link Capitol Corridor, future Sonoma-Marín Area Rail Transit (SMART) trains, and regional buses. In 2021, the STA Board officially designated the Suisun-Fairfield Capitol Corridor Station as the Solano Rail Hub and work has been underway to advance this future multi-modal mobility hub as envisioned in the State Rail Plan.

The Solano Rail Hub is a key piece of the state’s transportation and land use strategy, enabling local commerce, assisting in meeting regional housing needs, and delivering a seamless statewide transportation function. The Solano Rail Hub will be the most connected place in Solano County and since the cities of Suisun City and Fairfield have identified station-adjacent Priority Development Areas, the Suisun Waterfront PDA and the Heart of Fairfield PDA, the development of this station presents an important development opportunity for both cities. With that said, there is a need to develop a coordinated land use plan to create supportive land use density with housing and jobs in the two downtown PDAs.

The STA is seeking a consultant to prepare a Solano Rail Hub Residential Cluster PDA Plan for the cities of Suisun City and Fairfield. The objective is to develop a coordinated land use plan that would implement Transit Oriented Communities and create residential and mixed-use residential (including both affordable and market rate housing) synergy around the Solano Rail Hub. The Solano Rail Hub Residential Cluster Plan will be a planning document that will create a strong land use nexus with the Solano Rail Hub station, stimulating economic growth and revitalization in these communities, and will better position the two cities for future funding opportunities to develop their PDAs.

This plan is funded by a grant from the Metropolitan Transportation Commission (MTC) to support local implementation of Plan Bay Area 2050 Strategies, therefore, this project includes tasks needed to meet grant requirements.

### **FINAL PRODUCT**

The final product will be separate Priority Development Area Project Plan Reports for the City of Suisun City's Suisun Waterfront PDA and the City of Fairfield's Heart of Fairfield PDA, based on the tasks outlined below for each jurisdiction in the Scope of Services section of this RFP.

### **DISADVANTAGED BUSINESS ENTERPRISE (DBE) AND DISADVANTAGED VETERAN BUSINESS ENTERPRISE (DVBE) GOALS**

The STA has adopted a DBE goal which encourages the hiring of registered disadvantaged businesses which can be found at <https://sta.ca.gov/work-with-sta/procurement-opportunities/>. As this project is utilizing federal funds, the anticipated participation goal for DBE firms for this Project has been established at **10 percent (10%)**. Participation by a DBE consultant or subconsultants shall be in accordance with information contained in the Consultant Proposal DBE Commitment (Exhibit 10-01), or in the Consultant Contract DBE Information (Exhibit 10-02) attached to and incorporated as part of this contract. If a DBE subconsultant is unable to perform, CONSULTANT must make a good faith effort to replace him/her with another DBE subconsultant, if the goal is not otherwise met.

### **LOCAL PREFERENCE POLICY**

The STA has adopted a Local Preference Policy which encourages the hiring of local firms. While there is no adopted goal for this Project, firms are still encouraged to utilize the services of local firms in the preparation of a response to this RFP. The STA has prepared a database of contact information for local firms for convenience purposes only and without guarantees as to the ability of such firms to provide the services. ### **SCOPE OF SERVICE TASKS**

The STA intends to retain a qualified and committed professional planning, economic, data collection, and analysis firm (lead firm may have sub-consultants) to develop the following Plan reports. There shall be two Plan reports prepared, one for the City of the Suisun City's Suisun Waterfront PDA and one for the City of Fairfield's Heart of Fairfield PDA. Each report shall have the same tasks 1-6 and 8-10, with Task 7 being different for each jurisdiction as described below. In addition to these tasks, the selected consultant shall also include within the budget, 12 meetings that will include the consultant and project team.

The following details each task with deliverable information:

**Task 1. Budget and Schedule**

Develop detailed project budget and schedule. There will be a Kick-Off Meeting between STA and the selected consultant to negotiate the final budget and determine the final schedule with milestones to complete the tasks described in the Scope of Work.

**Task 2. TOC Policy and Rezoning**

**Task 2a – Identify actions to implement– MTC-adopted Transit Oriented Communities policy (TOC policy) in the project area.**

- Evaluate the applicability of various parts of the TOC policy to the project area.
- Recommend a strategy for implementing the applicable parts of the policy.
- Develop necessary materials for adoption.

**Task 2b – Rezoning of Residential and Mixed-Use Parcels**

Determine the need to rezone the identified public sites and other residential properties within the project area to meet the TOC policies for minimum density and potentially other standards (such as parking standards) for certain parcels.

- Inventory public sites and other residential/mixed use properties within the project area subject to TOC policies and identify their existing General Plan designation and zoning.
- Review relevant General Plan Elements, including but not limited to land use and housing, to ensure consistency with existing land use designations, policies, and programs.
- Review the Heart of Fairfield Plan and Certified EIR, Suisun Waterfront Specific Plan and the ongoing Suisun Waterfront Economic Development Strategy and Implementation Plan to ensure consistency with existing land use designations, policies, and land use regulations.
- Identify changes that will bring properties found to be inconsistent and recommend changes that will bring these elements, policies, and regulations into compliance with the TOC policies.
- Assist city staff in the zoning and general/specific plan/policy consistency process.
- Prepare a report that:
  - 1) Identifies any necessary zoning modifications, including draft language and findings to meet TOC policies.
  - 2) Identifies any necessary amendments required to General Plan elements and/or policies to ensure compliance.



- 3) Identifies any necessary amendments required to the Heart of Fairfield and Suisun Waterfront policies or regulations to ensure compliance.

### **Task 3. Flooding Impacts**

Evaluate both on-site and off-site flooding potential and identify on-site and offsite mitigation measures that can help protect the new development from flooding and help alleviate flooding in the area.

- Review available information and studies related to flood resilience as a part of flood risk management. Outline components and measures that could be included in a future Master Plan to reduce flood risk in the Study Area that utilize a combination of protection, prevention and preparedness.
- Using best practices, and available information and studies, evaluate the type of potential measures that could be implemented on a project specific basis that could help protect new development from flooding.
- Prepare a report:
  - 1) Identifies components and measures to be incorporated into a future Flood Risk Management Plan that would be prepared to address concerns related to the larger project, surrounding area and adjacent jurisdiction(s). In addition to physical measures, the analysis should also focus on flood resilience management practices.
  - 2) Identifies potential funding sources which can be used to prepare and implement the future Flood Risk Management Plan.
  - 3) Summarizing potential on-site and off-site mitigation measures that can be incorporated into new development to help mitigate the impact of potential flooding.

### **Task 4. Development Constraints**

Evaluate potential constraints to the development of the identified publicly owned sites:

- Identify physical, regulatory, or financial constraints to the development on the identified publicly owned sites. Constraints could include infrastructure (water,

sewer, utility relocation, flood issue, etc.) as well as regulatory issues (surplus land act, land use regulations or policies etc.), and development or other impact fees.

- Develop strategies to address/mitigate development constraints, including potential funding sources and processes or timelines to address said constraints.
- Prepare a report that:
  - 1) Summarizes the development constraints identified for the publicly owned sites.
  - 2) Outlines strategies to address and fund the identified constraints, including the future preparation of a Master Infrastructure Plan. The Plan would identify appropriate mitigation measures to address infrastructure (water, sewer, utility relocation, etc.) constraints to development within the Project Area. It would also identify potential funding sources for implementation of the Plan and timelines for funding for any future plans.

#### **Task 5. Development Strategies**

- Prepare a development strategy for publicly owned sites in Suisun City's and Fairfield's downtown area, using the Solano Rail Advanced Planning Study as a base.
- Develop prototype development pro-formas with site fit analysis of different types of residential and mixed-use development to determine market and financial feasibility for both for-rent and for-sale housing types, including affordable housing, at various densities.
- Prepare a report that:
  - 1) Includes a development strategy for publicly owned sites in the Suisun City and Fairfield downtown areas.
  - 2) Includes the market and financial feasibility of for-rent and for-sale housing types, including affordable housing, using development pro-formas with detailed assumptions. (e.g. parcel size and configuration and development constraints identified in Task 3 & 4).

#### **Task 6. Site Development**

Given the information from Tasks 3, 4 and 5, recommend a strategy for the development of each of the publicly owned sites to prepare and promote the development of these sites into residential and mixed-use residential (including affordable housing), including a timeline and implementation steps.

**Task 7. Parcel Consolidation and Housing Preservation**

**Task 7a. Parcel Consolidation for Heart of Fairfield PDA**

Evaluate strategies to encourage parcel consolidation in the Heart of Fairfield PDA. Using best practices, recommend strategies to encourage parcel consolidation to provide for larger development sites, while preserving affordability among existing residents.

**Task 7b. Housing Preservation for Suisun Waterfront PDA**

Using information, studies, and data previously prepared, develop a strategy for the preservation of affordable housing currently located in the Suisun Waterfront PDA. Evaluate information, studies and data previously prepared and prepare a strategy for the preservation of affordable housing currently located in the PDA.

**Task 8. Pedestrian and Bicycle Connection to the Solano Rail Hub and Downtown Suisun City and Fairfield**

The STA has developed plans to enhance the connection between downtown Suisun City and Fairfield and the Solano Rail Hub. The alternatives involve significant capital expenditures and are, therefore, a long-term potential solution. This task will evaluate short-term design concept guidelines that will enhance security and walkability of the existing pedestrian bridge and future pedestrian crossing (with an overhead or undercrossing option of both).

- Review Design Principles and Criteria for proposed improvements contained within the Solano Rail Hub Advanced Planning Study.
- Develop short-term design concept guidelines (including lighting, signage, landscaping, etc.) that enhance security and walkability of the existing pedestrian bridge and future pedestrian crossing (with an overhead or undercrossing option of both), that are consistent with these principles and criteria.

Short-term design concept guidelines, with estimated costs, to enhance the security and walkability of the existing pedestrian bridge and future pedestrian and bicycle crossing (with an overhead or undercrossing option of both)

**Task 9. Public Input**

- Develop and implement a public engagement process to include key stakeholders, public, landowners, non-profit and for-profit developers, residents and employees to solicit and report recommendations

Deliverable
1) Public and Key Stakeholder Engagement Plan 2) Meeting Agendas 3) Meeting Summaries with number of participants, targeted audience, input and recommendations received

**Task 10. MTC Plan Summary**

The Consultant shall complete the MTC Plan Summary providing information related to the tasks above. The Plan Summary consists of 12 questions (included as Attachment A) that quantifies the expected impact of the policies adopted as part of the MTC planning grant, and identifies potential synergies between PDA planning efforts and other MTC initiatives.

**Task 11. Draft and Final Report**

The Consultant will combine the previous deliverables to create an Administrative Draft Plan for STA staff, Solano EDC staff and member agency staff review. 1. *Examination of Proposal Documents:* By submitting a proposal, the proposer represents that it has thoroughly examined and become familiar with the work required under this RFP, and that it is capable of performing the work identified in Scope of Work.
2. *Addenda/Clarifications:* Explanations or clarifications desired by respondents regarding the meaning or interpretation of the RFP may be requested verbally or in writing. All inquiries pertaining to this RFP should be emailed to Kathrina Gregana at the following email address: [kgregana@sta.ca.gov](mailto:kgregana@sta.ca.gov) no later than **4:00 PM (local), July 26, 2024**. Response to all questions submitted by the deadline that may have a material impact on the proposal will be posted on the STA website at [www.sta.ca.gov](http://www.sta.ca.gov) by **August 2, 2024**. **A second Questions & Answers period is being allowed for this RFP, with additional questions emailed to Kathrina Gregana ([kgregana@sta.ca.gov](mailto:kgregana@sta.ca.gov)) no later than 4:00PM (local), August 16, 2024. Responses to the submitted questions will be posted on the STA website by August 21, 2024.** The subject line for questions submitted in writing should include reference to: "Questions - STA RFP #2024-03".
3. *Withdrawal of Proposal Submittal:* A proposer may withdraw its proposal at any time before the expiration of the time for submission of proposal submittals as provided in this RFP by delivering to the procurement officer a written request for withdrawal signed by, or on behalf of, the proposer.
4. *Rights of STA:* This RFP does not commit STA to enter into a contract, nor does it obligate STA to pay for any costs incurred in preparation and submission of the proposal or in anticipation of a contract.

STA may investigate the qualifications of any proposer under consideration, require confirmation of information furnished by the proposer, and require additional evidence or qualifications to perform the services described in this RFP.

**STA**, in its sole discretion, reserves the right to:

- Reject any or all proposal submittals.
- Issue one or more subsequent RFQs and/or RFPs.
- Postpone opening for its own convenience.
- Remedy technical errors in the RFQ and/or RFP process.
- Approve or disapprove the use of particular subcontractors.
- Negotiate with any, all, or none of the proposers responding to this RFP.
- Solicit best and final offers from all or some of the proposers.
- Award a contract to one or more proposers.
- Waive informalities and irregularities in any proposal.

5. *Method of Payment:* method of payment for this project is cost plus fixed fee. The submitted cost proposal (submitted separately from the technical proposal) must be in an appropriate format. If a proposer desires to take exception to the agreement, the proposer shall provide the following information as a section of the proposal identified as "Exceptions to the Agreement":

Proposer shall clearly identify each proposed change to the agreement, including all relevant exhibits and attachments.

- a. Proposer shall furnish the reasons therefore as well as specific recommendations for alternative language.
- b. The above factors will be taken into account in evaluating proposals. Substantial exceptions to the agreement may be determined by STA, at its sole discretion, to be unacceptable and STA may proceed with negotiations with the other proposed firms.

Please prepare your qualifications in accordance with the following requirements.

1. *Qualifications:* The qualifications (excluding resumes and the transmittal letter) shall not exceed a total of ten (10) single-sided, 8.5" x 11" pages. Include in the appendix similar examples of past projects.
2. *Transmittal Letter:* The qualifications shall be transmitted with a cover letter describing the firm's/team's interest and commitment to the proposed project. The letter shall state that the qualifications shall be valid for a 90-day period and should include the name, title, address and telephone number of the individual to whom correspondence and other contacts should be directed during the consultant selection process. The person authorized by the firm/team to negotiate a contract with STA shall sign the cover letter.

3. *Project Understanding:* This section shall clearly convey that the consultant understands the nature of the work, and issues related to the development of the Solano Rail Hub Residential Cluster PDA Plan.
4. *Approach and Management Plan:* This section shall provide the firm's/team's proposed approach and management plan for providing the services. Include an organization chart showing the proposed relationships among consultant staff, STA staff and any other parties that may have a significant role in the delivery of this project.

5. *Qualifications and Experience:* The qualifications submittal shall provide the qualifications and experience of the consultant team that will be available for the development of a Solano Rail Hub Residential Cluster PDA Plan. Please emphasize the specific qualifications and experience from projects similar to this project for the Key Team Members. Key Team Members are expected to be committed for the duration of the project. Replacement of Key Team Members will not be permitted without prior consultation with and approval of the STA.
6. *Staffing Plan:* The qualifications shall provide a staffing plan required for the Solano Rail Hub Residential Cluster PDA Plan. Discuss the workload, both current and anticipated, for all Key Team Members, and their capacity to perform the requested services for the development of a Solano Rail Hub Residential Cluster PDA Plan according to your proposed schedule. Discuss the firm/team's approach for completing the requested services for this project within budget.
7. *Work Plan and Schedule:* This section shall include a description and schedule of how each task deliverable of the project will be completed. 11. *Submittal of Proposal:* One (1) hard copy and one (1) digital copy (flash drive) of your proposal are due at the STA office **no later than 4:00 p.m., August 30, 2024**. Envelopes or packages containing the proposal should be clearly marked, "**RFP #2024-03**".
12. *Cost Proposal:* **A cost proposal should be submitted in a separate sealed envelope titled BUDGET.** The budget should indicate the number of anticipated hours by the Project Manager and Key Team Members. The estimated level of hours for other staff can be summarized in general categories. The submitted cost proposal must be in an appropriate format. ### **SELECTION OF CONSULTANT & CRITERIA**

The overall process will be to evaluate the technical components of all the qualifications completely and independently from the cost component. The qualifications will be evaluated and scored on a 100-point total basis using the following criteria:

1. Project understanding and approach (30 Points)
2. Experience with similar types of projects (25 Points)
3. Satisfaction of previous clients (10 Points)
4. Schedule and capacity to provide qualified personnel (25 Points)
5. Business presence and/or experience in Solano County (10 Points)

If needed, two or more of the firms/teams may be invited to an interview on or about **September 13, 2024**. The Project Manager and Key Team Members should attend the interview. The evaluation interview panel may include representatives from STA, and other agencies, but the specific composition of the panel will not be revealed prior to the interviews. Costs for travel expenses and qualifications preparation shall be borne by the consultants.

STA staff will provide the appropriate notice and schedule for the interviews. STA staff will select the most qualified consultant or consultant team based primarily on experience, ability to contain costs, and conducting very similar projects. Recent experience in Solano County is desirable.

Once the top firm/team has been selected, STA staff will negotiate a services contract with the selected firm/team.

The Consultant must ensure that DBEs and other small businesses have the opportunity to participate in the performance of the work that is the subject of this solicitation and should take all necessary and reasonable steps for this assurance. The proposer must not discriminate on the basis of race, color, national origin, or sex in the award and performance of subcontracts.
- B. Proposers are encouraged to use services offered by financial institutions owned and controlled by DBEs.

**3. SUBMISSION OF DBE INFORMATION**

If there is a DBE goal on the contract, Exhibit 10-O1 *Consultant Proposal DBE Commitment* must be included in the Proposal. In order for a proposer to be considered responsible and responsive, the proposer must make good faith efforts to meet the goal established for the contract. **4. DBE PARTICIPATION GENERAL INFORMATION**

- G. A prime consultant who is a certified DBE is eligible to claim all of the work in the Contract toward the DBE participation except that portion of the work to be performed by non-DBE subconsultants.

A DBE manufacturer is a firm that operates or maintains a factory, or establishment that produces on the premises the materials, supplies, articles, or equipment required under the Contract and of the general character described by the specifications.
- B. If the materials or supplies purchased from a DBE regular dealer, count 60 percent of the cost of the materials or supplies. A DBE regular dealer is a firm that owns, operates or maintains a store, warehouse, or other establishment in which the materials, supplies, articles or equipment of the general character described by the specifications and required under the Contract are bought, kept in stock, and regularly sold or leased to the public in the usual course of business. To be a DBE regular dealer, the firm must be an established, regular business that engages, as its principal business and under its own name, in the purchase and sale or lease of the products in question. A person may be a DBE regular dealer in such bulk items as petroleum products, steel, cement, gravel, stone or asphalt without owning, operating or maintaining a place of business provided in this section.
- C. - F. No alteration or variation of the terms of this contract shall be valid, unless made in writing and signed by the parties; and no oral understanding or agreement not incorporated in, shall be binding on any of the parties.
- G. The consideration to be paid to CONSULTANT under this contract shall be in compensation for all of CONSULTANT's expenses incurred in the performance of this contract, including travel and per diem, unless otherwise expressly so provided.

- D. All subcontracts in excess of \$25,000 shall contain the above provisions.

### **ARTICLE VIII RETENTION OF RECORDS/AUDIT**

For the purpose of determining compliance with Public Contract Code section 10115, et seq. and Title 21, California Code of Regulations, Chapter 21, Section 2500 et seq., when applicable and other matters connected with the performance of the contract pursuant to Government Code section 8546.7; CONSULTANT, subconsultants, and STA shall maintain and make available for inspection all books, documents, papers, accounting records, and other evidence pertaining to the performance of the contract, including but not limited to, the costs of administering the contract. All parties shall make such materials available at their respective offices at all reasonable times during the contract period and for three years from the date of final payment under the contract. The state, State Auditor, STA, FHWA, or any duly authorized representative of the Federal Government shall have access to any books, records, and documents of CONSULTANT and its certified public accountants (CPA) work papers that are pertinent to the contract and indirect cost rates (ICR) for audit, examinations, excerpts, and transactions, and copies shall be furnished if requested. Subcontracts in excess of \$25,000 shall contain this provision.

### **ARTICLE IX AUDIT REVIEW PROCEDURES**

- A. Any dispute concerning a question of fact arising under an interim or post audit of this contract that is not disposed of by agreement, shall be reviewed by STA'S Executive Director.
- B. Not later than 30 days after issuance of the final audit report, CONSULTANT may request a review by STA'S Executive Director of unresolved audit issues. The request for review will be submitted in writing.

The Cost Proposal shall be adjusted by the CONSULTANT and approved by the STA Contract Administrator to conform to the Work Paper Review recommendations included in the management letter or audit recommendations included in the audit report. Refusal by the CONSULTANT to incorporate the Work Paper Review recommendations included in the management letter or audit recommendations included in the audit report will be considered a breach of the contract terms and cause for termination of the contract and disallowance of prior reimbursed costs.
1. During a Caltrans' review of the ICR audit work papers created by the CONSULTANT's independent CPA, Caltrans will work with the CPA and/or CONSULTANT toward a resolution of issues that arise during the review. Each party agrees to use its best efforts to resolve any audit disputes in a timely manner. If Caltrans identifies significant issues during the review and is unable to issue a cognizant approval letter, STA will reimburse the CONSULTANT at a provisional ICR until a FAR compliant ICR {e.g. 48 CFR, part 31; GAGAS (Generally Accepted Auditing Standards); CAS (Cost Accounting Standards), if applicable; in accordance with procedures and guidelines of the American Association of State Highways and Transportation Officials Audit Guide; and other applicable procedures and guidelines} is received and approved by A&I. Provisional rates will be as follows:
    - a. If the proposed rate is less than 150% - the provisional rate reimbursed will be 90% of the proposed rate.

- C. CONSULTANT shall pay its subconsultants within ten (10) calendar days from receipt of each payment made to CONSULTANT by STA.
- D. Any subcontract in excess of \$25,000 entered into as a result of this contract shall contain all the provisions stipulated in this contract to be applicable to subconsultants.
- E. Any substitution of subconsultant(s) must be approved in writing by STA's Contract Administrator prior to the start of work by the subconsultant(s).

#### ARTICLE XI EQUIPMENT PURCHASE

- A. Prior authorization in writing, by STA's Contract Administrator shall be required before CONSULTANT enters into any unbudgeted purchase order, or subcontract exceeding \$5,000 for supplies, equipment, or CONSULTANT services. CONSULTANT shall provide an evaluation of the necessity or desirability of incurring such costs.
- B. For purchase of any item, service or consulting work not covered in CONSULTANT's Cost Proposal and exceeding \$5,000 prior authorization by STA's Contract Administrator; three competitive quotations must be submitted with the request, or the absence of bidding must be adequately justified.
- C. Any equipment purchased as a result of this contract is subject to the following: "CONSULTANT shall maintain an inventory of all nonexpendable property. Nonexpendable property is defined as having a useful life of at least two years and an acquisition cost of \$5,000 or more. If the purchased equipment needs replacement and is sold or traded in, STA shall receive a proper refund or credit at the conclusion of the contract, or if the contract is terminated, CONSULTANT may either keep the equipment and credit STA in an amount equal to its fair market value, or sell such equipment at the best price obtainable at a public or private sale, in accordance with established STA procedures; and credit STA in an amount equal to the sales price. If CONSULTANT elects to keep the equipment, fair market value shall be determined at CONSULTANT's expense, on the basis of a competent independent appraisal of such equipment. Appraisals shall be obtained from an appraiser mutually agreeable to by STA and CONSULTANT, if it is determined to sell the equipment, the terms and conditions of such sale must be approved in advance by STA." 49 CFR, Part 18 requires a credit to Federal funds when participating equipment with a fair market value greater than \$5,000 is credited to the project.
- D. All subcontracts in excess \$25,000 shall contain the above provisions.

### **ARTICLE XIV REBATES, KICKBACKS OR OTHER UNLAWFUL CONSIDERATION**

CONSULTANT warrants that this contract was not obtained or secured through rebates kickbacks or other unlawful consideration, either promised or paid to any STA employee. For breach or violation of this warranty, STA shall have the right in its discretion; to terminate the contract without liability; to pay only for the value of the work actually performed; or to deduct from the contract price; or otherwise recover the full amount of such rebate, kickback or other unlawful consideration.

### **ARTICLE XV PROHIBITION OF EXPENDING STA STATE OR FEDERAL FUNDS FOR LOBBYING**

Any person who fails to file the required certification shall be subject to a civil penalty of not less than \$10,000 and not more than \$100,000 for each such failure.
- C. CONSULTANT also agrees by signing this document that he or she shall require that the language of this certification be included in all lower-tier subcontracts, which exceed \$100,000 and that all such sub recipients shall certify and disclose accordingly.

- A. - B. CONSULTANT's signature affixed below shall constitute a certification under penalty of perjury under the laws of the State of California, that CONSULTANT has complied with Title 2 CFR, Part 180, "OMB Guidelines to Agencies on Government wide Debarment and Suspension (nonprocurement)", which certifies that he/she or any person associated therewith in the capacity of owner, partner, director, officer, or manager, is not currently under suspension, debarment, voluntary exclusion, or determination of ineligibility by any federal agency; has not been suspended, debarred, voluntarily excluded, or determined ineligible by any federal agency within the past three (3) years; does not have a proposed debarment pending; and has not been indicted, convicted, or had a civil judgment rendered against it by a court of competent jurisdiction in any matter involving fraud or official misconduct within the past three (3) years. Any exceptions to this certification must be disclosed to STA.

- B. This contract is valid and enforceable only, if sufficient funds are made available to STA for the purpose of this contract. In addition, this contract is subject to any additional restrictions, limitations, conditions, or any statute enacted by the Congress, State Legislature, or STA governing board that may affect the provisions, terms, or funding of this contract in any manner.
- C. It is mutually agreed that if sufficient funds are not appropriated, this contract may be amended to reflect any reduction in funds.
- D. STA has the option to void the contract under the 30-day termination clause pursuant to Article VI, or by mutual agreement to amend the contract to reflect any reduction of funds.

#### **ARTICLE XIX CHANGE IN TERMS**

- A. This contract may be amended or modified only by mutual written agreement of the parties.
- B. CONSULTANT shall only commence work covered by an amendment after the amendment is executed and notification to proceed has been provided by STA's Contract Administrator.
- C. There shall be no change in CONSULTANT's Project Manager or members of the project team, as listed in the approved Cost Proposal, which is a part of this contract without prior written approval by STA's Contract Administrator.

#### **ARTICLE XX DISADVANTAGED BUSINESS ENTERPRISES (DBE) PARTICIPATION**

Consultants who obtain DBE participation on this contract will assist Caltrans in meeting its federally mandated statewide overall DBE goal.

CONSULTANT or subconsultant shall not discriminate on the basis of race, color, national origin, or sex in the performance of this contract. CONSULTANT shall carry out applicable requirements of 49 CFR, Part 26 in the award and administration of US DOT-assisted agreements. Failure by CONSULTANT to carry out these requirements is a material breach of this contract, which may result in the termination of this contract or such other remedy as STA deems appropriate.

- D. Any subcontract entered into as a result of this contract shall contain all of the provisions of this section.
- E. A DBE firm may be terminated only with prior written approval from STA and only for the reasons specified in 49 CFR 26.53(f). Prior to requesting STA consent for the termination, CONSULTANT must meet the procedural requirements specified in 49 CFR 26.53(f).
- F. A DBE performs a Commercially Useful Function (CUF) when it is responsible for execution of the work of the contract and is carrying out its responsibilities by actually performing, managing, and supervising the work involved. To perform a CUF, the DBE must also be responsible with respect to materials and supplies used on the contract, for negotiating price, determining quality and quantity, ordering the material, and installing (where applicable) and paying for the material itself. To determine whether a DBE is performing a CUF, evaluate the amount of work subcontracted, industry practices, whether the amount the firm is to be paid under the contract is commensurate with the work it is actually performing, and other relevant factors.
- G. A DBE does not perform a CUF if its role is limited to that of an extra participant in a transaction, contract, or project through which funds are passed in order to obtain the appearance of DBE participation. The amount will be returned to CONSULTANT when a satisfactory "Final Report-Utilization of Disadvantaged Business Enterprises (DBE), First-Tier Subconsultants" is submitted to the Contract Administrator.
- K. If a DBE subconsultant is decertified during the life of the contract, the decertified subconsultant shall notify CONSULTANT in writing with the date of decertification. If a subconsultant becomes a certified DBE during the life of the Contract, the subconsultant shall notify CONSULTANT in writing with the date of certification. Any changes should be reported to STA's Contract Administrator within 30 days.

### ARTICLE XXI CONTINGENT FEE

CONSULTANT warrants, by execution of this contract that no person or selling agency has been employed, or retained, to solicit or secure this contract upon an agreement or understanding, for a commission, percentage, brokerage, or contingent fee, excepting bona fide employees, or bona fide established commercial or selling agencies maintained by CONSULTANT for the purpose of securing business. For breach or violation of this warranty, STA has the right to annul this contract without liability; pay only for the value of the work actually performed, or in its discretion to deduct from the contract price or consideration, or otherwise recover the full amount of such commission, percentage, brokerage, or contingent fee.

**ARTICLE XXII DISPUTES**

CONSULTANT and any subconsultant shall permit STA, the state, and the FHWA if federal participating funds are used in this contract; to review and inspect the project activities and files at all reasonable times during the performance period of this contract including review and inspection on a daily basis.

**ARTICLE XXIV SAFETY**

- A. CONSULTANT shall comply with OSHA regulations applicable to CONSULTANT regarding necessary safety equipment or procedures. CONSULTANT shall comply with safety instructions issued by STA Safety Officer and other STA representatives. CONSULTANT personnel shall wear hard hats and safety vests at all times while working on the construction project site.
- B. Pursuant to the authority contained in Section 591 of the Vehicle Code, STA has determined that such areas are within the limits of the project and are open to public traffic. CONSULTANT shall comply with all of the requirements set forth in Divisions 11, 12, 13, 14, and 15 of the Vehicle Code. CONSULTANT shall take all reasonably necessary precautions for safe operation of its vehicles and the protection of the traveling public from injury and damage from such vehicles.
- C. Any subcontract entered into as a result of this contract, shall contain all of the provisions of this Article.

#### ARTICLE XXV INSURANCE AND INDEMNIFICATION

A. CONSULTANT shall procure and maintain for the duration of this Contract the following insurance:

##### **Minimum Scope of Insurance:**

Coverage shall be at least as broad as:

1. Insurance Services Office Commercial General Liability coverage ("occurrence" form CG 0001).
2. Insurance Services Office form number CA 0001 (Ed. 1/87) covering Automobile Liability, code 1 (any auto). If CONSULTANT owns no vehicles, this requirement may be satisfied by a non-owned auto endorsement to the general liability policy described above. If CONSULTANT or CONSULTANT's employees will use personal autos on this project, CONSULTANT shall obtain evidence of personal auto liability coverage for each person.
3. Workers' Compensation insurance as required by the State of California and Employer's Liability insurance.
4. Errors and Omissions liability insurance appropriate to the CONSULTANT's profession. Architect's and engineers' coverage is endorsed to include contractual liability.

##### **Minimum Limits of Insurance:**

CONTRACTOR shall maintain limits no less than:

1. General Liability: \$2,000,000 per occurrence for bodily injury, personal injury and property damage. If Commercial General Liability Insurance or other form with a general aggregate limit is used, either the general aggregate limit shall apply separately to this location or the general aggregate limit shall be twice the required occurrence limit.
2. Automobile Liability: \$2,000,000 per accident for bodily injury and property damage, combined single limit.
3. Employer's Liability: \$2,000,000 per accident for bodily injury or disease, and in the aggregate.
4. Errors and Omissions Liability: \$1,000,000 on a claims made basis.

##### **Deductibles and Self-Insurance Retentions:**

Any deductibles or self-insured retentions exceeding \$50,000 must be declared to and approved by the STA. At the option of STA, either: the CONSULTANT shall reduce or eliminate such deductibles or self-insured retentions regarding the STA, its officers, officials, employees and volunteers; or CONSULTANT shall provide a financial guarantee satisfactory to the STA guaranteeing payment of losses and related investigations, claim administration and defense expenses.

##### **Other Insurance Provisions:**

The general liability and automobile liability policies must contain, or be endorsed to contain, the following provisions:

1. The STA, its officers, officials, employees and volunteers be covered as insureds regarding the liability arising out of automobiles owned, leased, hired or borrowed by or for the CONSULTANT, and regarding liability arising out of work or operations by or for the CONSULTANT including materials, parts or equipment furnished with such work or operations.

General liability coverage can be in an endorsement to the CONSULTANT's insurance or as a separate owner's policy.

#### **Acceptability of Insurers:**

Insurance is placed with insurers with a current A.M. Best's rating of no less than A:VII, unless otherwise acceptable to STA.

#### **Verification of Coverage:**

CONSULTANT shall furnish STA with original certificate and amendatory endorsements effecting coverage required by this clause. All certificates and endorsements must be received and approved by the STA before work commences. STA reserves the right to require complete, certified copies of all required insurance policies, including endorsements effecting coverage required by these specifications.

#### **Sub-Contractors:**

CONSULTANT shall include all sub-contractors as insureds under its policies or shall furnish separate certificates and endorsements for each sub-contractor. All coverages for sub-contractors shall be subject to all of the requirements stated above unless specifically waived by STA in writing.

B. CONSULTANT shall indemnify and hold harmless the STA, its officers, officials, employees and volunteers against all actions, causes of actions, damages, costs, liabilities, claims, losses, judgments, penalties and expenses of every type and description, including without limitation any fees and/or costs reasonably incurred by STA's staff attorneys or contract attorneys and any and all costs, fees and expenses incurred in enforcing this provision (collectively referred to as "liabilities"), arising out of or for any negligent act or omission, misconduct or other legal fault of CONSULTANT, its officers, employees, sub-contractors, subcontractors or agents in connection with the performance or nonperformance of this Contract, whether or not STA accepted or approved any service or work product performed or provided by CONSULTANT, and whether or not such liabilities are litigated, settled or reduced to judgment. If a final decision or judgment allocates liability by determining any portion of damages awarded is attributable to STA's negligence or willful misconduct, STA shall pay the portion of damages allocated to STA's negligence or willful misconduct, provided that STA shall not be liable for any passive negligence of STA, its officers, officials, employees and volunteers in reviewing, accepting or approving any service or work product performed or provided by CONSULTANT.

CONSULTANT shall, upon STA's request, defend with counsel approved by STA (which approval shall not be unreasonably withheld), at CONSULTANT's sole cost and expense, any action, claim, suit, cause of action

or portion which asserts or alleges liabilities resulting from any allegedly negligent act, omission, misconduct or other legal fault of CONSULTANT, its officers, employees, sub-contractors, subcontractors or agents in connection with the performance or nonperformance of this Contract, whether or not such action, claim, suit, cause of action or portion is well founded or lacking in merit.

Acceptance of required insurance certificates or endorsements does not relieve CONSULTANT from liability under this contract and shall apply to all damages and claims of every kind suffered, or alleged to have been suffered, by CONSULTANT's negligence, misconduct, or other legal fault whether such insurance policies shall have been determined to apply to such damages or claims for damages. This Article shall survive any termination of this contract.

#### **ARTICLE XXVI OWNERSHIP OF DATA**

- A. Upon completion of all work under this contract, ownership and title to all reports, documents, plans, specifications, and estimates produce as part of this contract will automatically be vested in STA; and no further agreement will be necessary to transfer ownership to STA. CONSULTANT shall furnish STA all necessary copies of data needed to complete the review and approval process.
- B. It is understood and agreed that all calculations, drawings and specifications, whether in hard copy or machine-readable form, are intended for one-time use in the construction of the project for which this contract has been entered into.
- C. CONSULTANT is not liable for claims, liabilities, or losses arising out of, or connected with the modification, or misuse by STA of the machine-readable information and data provided by CONSULTANT under this contract; further, CONSULTANT is not liable for claims, liabilities, or losses arising out of, or connected with any use by STA of the project documentation on other projects for additions to this project, or for the completion of this project by others, except only such use as many be authorized in writing by CONSULTANT.
- D. Applicable patent rights provisions regarding rights to inventions shall be included in the contracts as appropriate (48 CFR 27, Subpart 27.3 - Patent Rights under Government Contracts for federal-aid contracts).
- E. STA may permit copyrighting reports or other agreement products. If copyrights are permitted; the agreement shall provide that the FHWA shall have the royalty-free nonexclusive and irrevocable right to reproduce, publish, or otherwise use; and to authorize others to use, the work for government purposes.
- F. Any subcontract in excess of \$25,000 entered into as a result of this contract, shall contain all of the provisions of this Article.

#### **ARTICLE XXVII CLAIMS FILED BY STA'S CONSTRUCTION CONTRACTOR**

- A. If claims are filed by STA's construction contractor relating to work performed by CONSULTANT's personnel, and additional information or assistance from CONSULTANT's personnel is required in order to evaluate or defend against such claims; CONSULTANT agrees to make its personnel available for consultation with STA'S construction contract administration and legal staff and for testimony, if necessary, at depositions and at trial or arbitration proceedings.
- B. CONSULTANT's personnel that STA considers essential to assist in defending against construction contractor claims will be made available on reasonable notice from STA. Consultation or testimony will be reimbursed at the same rates, including travel costs that are being paid for CONSULTANT's personnel services under this contract.

- C. Services of CONSULTANT's personnel in connection with STA's construction contractor claims will be performed pursuant to a written contract amendment, if necessary, extending the termination date of this contract in order to resolve the construction claims.
