Minutes for the Meeting of October 3, 2024

1. CALL TO ORDER/CONFIRM QUORUM

The meeting of the STA's Pedestrian Advisory Committee (PAC) was called to order by Chair Diane Dooley at approximately 6:00 p.m. Quorum was confirmed.

2. APPROVAL OF AGENDA

On a motion as amended by Teri Booth and a second by Cookie Clark, the STA PAC approved the agenda with the correction for the next meeting date to be on Thursday, December 5, 2024. (8 Ayes)

3. OPPORTUNITY FOR PUBLIC & STAFF COMMENTS

Dulce Jimenez announced the 27th STA Annual Awards will be held in the City of Rio Vista at the Municipal Airport Hanger on Wednesday, November 13, 2024.

4. CONSENT CALENDAR

A. PAC MEETING MINUTES

Recommendation:

Approve STA PAC Meeting Minutes of August 1, 2024.

On a motion by Teri Booth, and a second by Joe Green-Heffern the STA PAC approved the Consent Calendar Item A. (8 Ayes).

5. PRESENTATIONS

A. Patwino Worrtla Kodoi Dihi Open Space Park

Nicole Braddock, Executive Director of the Solano Land Trust presented on the agency's role in building partnerships to protect land for agriculture, modeling stewardship, and expanding opportunities for meaningful outdoor experiences. A second part to Mrs. Braddock's presentation included discussing the recently constructed Patwino Worrtla Kodoi Dihi Open Space park, which includes park amenities including bathroom and water access, along with picnic tables and benches throughout the park. The park also has an All People's Trail that meets outdoor accessibility standards. With this major project completed, Mrs. Braddock was also able to discuss the longer-term vision of the agency, which was to get 100% of Solano youth outdoors, inspire kids in STEM, increase engagement and access to outdoor spaces, particularly for underrepresented communities, and will be looking to partner with 1st 5 Solano, Solano County Office of Education, and Solano County Behavioral Health to collaborate and seek grant funding to increase opportunities for Solano youth to access the outdoors.

6. ACTION ITEM – NON-FINANCIAL

A. Regional Measure (RM) 3 Safe Routes to Transit and Bay Trail (SR2TBT) Program Complete Streets Checklists and Letters of Support

Dulce Jimenez stated that Cycle 1 of the Safe Routes to Transit Bay Trail (SR2TBT) Program has \$50 million available for competitive projects, with \$25 reserved for transformative projects. The grant is available for a wide range of applicants including cities, counties, transit operators, school districts, and community colleges and universities. As part of the grant application, member agencies needed to submit complete streets checklists which Ms. Jimenez reminded the committee members to review and provide comments by noon October 7, 2024. A second part to this agenda item included the recommendation from the committee to forward the recommendation to the STA Board to issue letters of support to the four-member agencies submitting projects for Cycle 1 of the SR2TBT program.

Summary of Committee Members:

Bob Berman concurred with supporting the Vallejo Bluff Trail project, emphasizing its proximity to the Carquinez Bridge, which is one of the criteria identified for the grant. Additionally, the alignment is a critical gap closure alignment identified by the three regional trail organizations (e.g. Bay Area Ridge Trial, San Francisco Bay Trail, and the Great California Delta Trail).

Joe Green-Heffern provided a suggestion to strengthen the Suisun City McCoy Creek Trail Phase III project by encouraging Suisun City staff to discuss the Suisun City Microtransit school tripper that passes on Pintail Drive during the school year. Mr. Heffern also mentioned how City of Fairfield residents may take the bus to the adjacent community center, which opens up their opportunity to walk the trail.

Chair Dooley concurred with supporting the City of Benicia Military East Sidewalk Gap Closure Project, noting how the project would increase pedestrian safety along the corridor by creating a connected ADA-compliant walking network.

Recommendation:

Forward a recommendation to the STA Board to issue letters of support for the following member agency projects, which are also captured in the STA Active Transportation Plan:

- A. City of Benicia Military East Sidewalk Gap Closure
- B. City of Suisun City McCoy Creek Phase III
- C. City of Vallejo Vallejo Bluff Trail
- D. Unincorporated County of Solano Benicia Road Complete Streets Project Phase II

On a motion by Joe Green-Heffern, and a second by Cookie Clark the STA PAC approved the Recommendation(8 Ayes).

B. Draft List of Recommended Walks for the Volume II of the Walking Brochure

Dulce Jimenez provided a high level summary outlining the process, walking scores and proposed walking routes for the second volume of the walking brochure.

On a motion by Jacob Francisco, and a second by Dennis Elliott, the Joint Special Committee approved the agenda unanimously (12 Ayes)

4. PRESENTATIONS

A. Introduction to the Napa Valley Vine Trail

Shawn Casey-White, Napa Valley Vine Trail, was unable to attend the meeting and may present at a future advisory committee.

5. ACTION FINANCIAL ITEMS

A. Transportation Development Act Article 3 (TDA-3) Fiscal Year (FY) 2025-26 Funding Recommendation for State Route (SR) 37/Fairgrounds Drive Interchange Project

This project was presented by Nick Burton, Director of Projects.

Summary of Committee Members and Public Comments:

BAC and PAC members observed that the funding allocation for the State Route 37/Fairgrounds Drive Interchange Project was a substantial funding request, and if the allocation is recommended by the two committees, it would decrease the funding capacity for other active transportation projects across that are submitted for to be considered for the remaining TDA-3 funds for Fiscal Year (FY) 2025-26. Further discussion on the remaining TDA-3 funding for FY25-26 concluded with committee members requesting STA staff provide a summary of previous TDA-3 allocations and to proactively continue to work with member agency staff to identify future active transportation projects and as needed support with the development of the project funding plans which may include leveraging other STA discretionary fund sources such as the Bay Area Air Quality Management District (BAAQMD) Transportation Fund for Clean Air (TFCA) 40% Fund.

As part of the follow-up conversation on the funding plan for the project, Mr. Burton clarified that the County of Solano has been a valuable partner and will be contributing about \$4 million for the construction of the project. Mr. Burton also clarified that even though Six Flags Discovery Kingdom may not have contributed funds for construction, they have been in support of the project and helped provide funding for the design costs.

Various committee members provided similar comments on the importance of the SR37 Fairgrounds Drive Interchange Project, highlighting the project benefits of increasing transportation efficiency for users of the SR37 corridor. The project will also enhance the biking and walking infrastructure that connects the two communities divided by the SR37 corridor.

Nancy Lund, wanting to understand the current biking and walking potential on the project site, requested STA staff provide an estimated number of biking and walking trips for the corridor. In response, STA staff provided a back-of-the-napkin calculation using Big Data via the Replica platform, on an average Thursday in Spring 2024 there were roughly 287 trips by both (250) pedestrians and (37) bicyclists estimated to use the corridor daily.

Joe Green-Heffern wanted to understand why the bids for the project were higher than the engineer's estimate. In response, STA staff noted that the cost of materials was higher, such as the cost of concrete or transit components for the signal priority for the transit buses.

David George asked why federal funds were not utilized for this project, Nick Burton indicated staff did seek out federal grant opportunities but unfortunately were not successful in receiving federal grant awards.

Neil Iverson expressed his support for complete street projects and provided additional context to explain his stance against allocating additional TDA-3 funding for the project.

PAC Chair Dooley, Jason Gray, and Dennis Elliott were interested in understanding collision data on pedestrians/bicyclists using facilities that have a Diverging Dimond Interchange Design. STA staff noted their comments.

Jacob Francisco expressed support for the construction of the SR37 Fairgrounds Drive Interchange Project to alleviate the congestion on Highway 37.

Recommendation:

Forward a recommendation to the STA TAC and STA Board to approve the funding allocation of \$400,000 in Fiscal Year 2025-2026 Transportation Development Act Article 3 (TDA-3) funds for the State Route 37/Fairgrounds Drive Interchange Project.

The Bicycle Advisory Committee Members had one motion on the table summarized below:

On a motion by Jacob Francisco and a second by Dennis Elliott, the BAC amended the recommendation with the stipulation that if all funds are not ascertained for this project as shown in Attachment A the funds will return to the TDA-3 funding pot.

BAC Vote: 5 Ayes, 1 Nays (Neil Iverson)

After a lengthy discussion, the Pedestrian Advisory Committee Members had two motions on the table summarized below:

- 1. Bob Berman made a motion to not recommend STA staff's recommendation. This motion was seconded by Diane Dooley, however, the motion failed with the following resulting votes:
 - 3 Ayes (Bob Berman, Diane Dooley, David George)
 - 3 Nays (Joseph Green-Heffern, Avery Livengood, and Cookie Clark)
- 2. On a motion by Joe Green-Heffern, and a second by Cookie Clark, the motion passed to approve the STA staff recommendation with the *stipulation that the rest of the identified funding sources in the funding plan shown in Attachment A are secured for the project. If the funds in the funding plan are not secured, the TDA-3 allocation will return to the committee to reallocate to another competitive project.*
 - 2 Nays (Bob Berman, Diane Dooley)
 - 3 Ayes (Joseph Green-Heffern, Avery Livengood, Cookie Clark, David George)

6. INFORMATION – DISCUSSION

A. 2025 Draft Work Plans for the Bicycle Advisory Committee (BAC) and Pedestrian Advisory Committee (PAC)

Dulce Jimenez provided a draft of the 2025 work plans for the coming year for committees to review and provide further ideas and changes for a future vote at the next meetings.

7. MEMBER UPDATES / ROUNDTABLE

BAC Chair Belef encouraged all members to provide feedback to the Solano County Board of Supervisors on the Fairgrounds 360 project and to consider pedestrian and bicycle planning since it has yet to be finalized. He also mentioned the upcoming Mad Hatter Parade in Vallejo.

Joe Green-Heffern mentioned a \$750,000 grant awarded to Solano County for the Farm to Market Phase 4 Project in Suisun Valley, involves improvements to bike lanes and pedestrian facilities.

Neil Iverson announced that Ray's Cycle will be hosting the final Candy Cane Lane Ride. Mr. Iverson also announced that Ray's Cycle won Business of the Year at the 27th STA Annual Awards, and is saddened by the shop's upcoming closure.

Glenn Giovannoni announced he has applied as the new Rio Vista PAC representative.

Background:

The PAC has two office positions, Chair and Vice Chair, to assist Solano Transportation Authority (STA) staff in developing agendas and running meetings. Under Article 5, Section 2 of the PAC Bylaws it states the PAC must select a Chair and Vice Chair at the last meeting of each calendar meeting. However, since the latest PAC meeting was held jointly with the Bicycle Advisory Committee (BAC) the selection of a Chair and Vice Chair was postponed to the February 6, 2025 meeting.

The role of the Chair is to preside over PAC meetings and coordinate the meeting agendas with STA staff. The role of the Vice Chair is to assist the Chair and to preside over the meeting in the absence of the Chair. The Chair and Vice Chair serve one calendar year terms, while no officer is allowed to serve more than two consecutive terms in office. The new positions for Chair and Vice-Chair will be in effect starting April 3, 2025.

Discussion:

Chair Diane Dooley, representing the City of Benicia, and Vice Chair Joe Green-Heffern, representing the City of Fairfield have served in their current position for the last calendar year and are eligible for reelection. Both have expressed interest in continuing in their roles for another calendar year.

During their time as respective PAC Chair and Vice Chairs, they have overseen the allocation of \$535,190 in Transportation Development Act Article 3 (TDA-3) funds and have continued to support the PAC and STA staff with the implementation of the Solano Active Transportation Plan.

In accordance with the PAC Bylaws, STA staff recommend electing a Chair and Vice Chair to serve during the 2025 calendar year.

Background:

The Solano Transportation Authority's (STA) Comprehensive Transportation Plan (CTP) serves as the primary long-range planning document that guides and prioritizes the STA's investments in transportation. It also serves as the foundational document from which transportation projects and programs are considered for the Metropolitan Transportation Commission's (MTC) Regional Transportation Plan (RTP) called Plan Bay Area (PBA). The STA kicked off an update to the current CTP in January 2023 by forming committees for each of the CTP Elements: 1) Active Transportation Element, 2) Arterials, Highways and Freeways Element and 3) Transit and Rideshare Element. The CTP update is anticipated to be completed by the end of 2025.

At this point the three CTP subcommittees have held two to three meetings each and have completed the draft goals and objectives for their respective elements. The latest Active Transportation Element goals and objectives have been formally approved by the Active Transportation Committee at their July 17, 2024 meeting, while the other two elements are still pending formal approval by their respective policy committees. The next set of Spring 2025 CTP subcommittee element meetings will occur in the following days:

- Active Transportation Committee February 12, 2024 from 4:00-5:30 p.m.
- Arterials/Highways/Freeways March 12, 2025 from 4:00-5:30 p.m.
- Transit Element Committee April 9, 2025 4:00 5:30 p.m.

Discussion:

In early 2023, the PAC nominated and elected Bob Berman to represent the PAC in the Active Transportation Committee (ATC), and Teri Booth to represent the PAC in the Arterials/Highways and Freeways (AHF) Committee, in which they have both provided valuable insight at each of their respective subcommittee meetings. Since it has been two calendar years since their original appointment, and with the addition of new PAC committee members since their original appointment, the two (2) positions will be up for nomination and election. The new term will be for calendar years 2025-2026. Former representatives for the ATC and AHF are eligible for reelection.

Additionally, in the upcoming 2025 CTP subcommittee element meeting, committee members will preview the draft Project Prioritization Criteria (Attachment B) which was designed to align with the goals and objectives for each element. The purpose of the Project Prioritization Criteria is to categorize identified transportation projects and programs into priority tiers as a part of the CTP process. This approach ensures that the highest-priority projects that closely align with the overall goals and objectives of the CTP are the most competitive for funding sources.

STA staff encourage PAC committee members to review and provide comments to STA staff, Dulce Jimenez at <u>djimenez@sta.ca.gov</u>. Any comments submitted will also be shared with the BAC representatives that are nominated and elected into these positions.

INTRODUCTION

The purpose of this memorandum is to present an approach for prioritizing the list of projects that were identified as part of the Comprehensive Transportation Plan process. The plan will include projects that have previously been identified as well as newly identified projects, and each project will fall under one or more of the modal elements, including:

- Active Transportation
- Arterials, Freeways, and Highways
- Transit and Rideshare

This approach includes a summary of the prioritization process, identification of prioritization categories, and review of the criteria used for scoring. While the prioritization methodology will be made as universally applicable as possible, it recognizes that there are project and mode specific factors that do not apply to all projects and include a mode specific category that can be customized for each project as relevant. For example, different modes have different average trip lengths, and so their effect on travel patterns will be scored differently.

PRIORITIZATION CATEGORIES

Prioritization categories have been selected to align with the goal and objective statements identified for the plan and for each element. Additionally, there will be two additional categories (Local Needs and Priorities; Mode-Specific Factors) that will allow for some level of customized scoring across projects. The proposed prioritization categories are as follows:

 Mobility and Connectivity – Improving mobility and connectivity for all users of the regional transportation system

- Accessibility Closing gaps and improving access to key destinations
- Safety Improving Safety and reducing existing crash rates and severity
- Sustainability and Resiliency Creating a sustainable and resilient transportation system
- Equity Investing in an equitable and inclusive transportation system
- System Maintenance Maintaining existing infrastructure
- Funding Availability of funds or funding source(s)
- Local Needs and Priorities Aligning with local transportation needs and priorities
- Mode-Specific Factors Varies by mode

PRIORITIZATION SCORING CRITERIA

Each prioritization category has been given a recommended scoring criterion based on various factors related to each category. **Table 1** provides scoring criteria that can be applied across all projects regardless of mode. The Regional Transportation Network is a proxy term that refers to a combination of the Routes of Regional Significance, the Active Transportation Backbone Network, and Regional Transit hubs and routes (see attached **map series**).

In addition to the scoring criteria that can be applied to projects regardless of mode, there are scoring criteria that are only relevant to one or more specific modes (see **Table 2**).

Background:

The Pedestrian Advisory Committee (BAC) act to advise the STA Board on the planning, funding, and implementation of countywide bicycle-related projects, facilities, and programs.

Each calendar year, STA staff work with the PAC to create a calendar year work plan that will guide the agendas and work products for the PAC to anticipate for the upcoming year.

In 2024, the PAC was essential in coordinating with STA staff to prioritize projects to allocate \$535,190 in Fiscal Year (FY) 2024-25 Transportation Development Act Article 3 (TDA-3) funds.

Discussion:

STA staff in collaboration with Chair Dooley and Vice Chair Green-Heffern developed an updated 2025 Draft PAC Work Plan that focus on five (5) main goals for the PAC to focus on in 2025:

- 1. ENGAGE A REPRESENTATIVE PEDESTRIAN ADVISORY COMMITTEE: Support in the recruitment of any vacant positions on the PAC. The goal of the PAC is to have full representation from all the eight Solano jurisdictions. STA staff will provide relevant and appropriate enrichment materials for a fully engaged PAC.
- PRIORITIZE FUNDING: Discuss and provide constructive feedback on proposed active transportation projects put forth by the STA and/or City/County staff. Support STA staff and/or City/County staff in their pursuit of active transportation grant opportunities for projects identified in the 2020 Active Transportation Plan and upcoming Comprehensive Transportation Plan.
- 3. ADVOCATE FOR PEDESTRIAN IMPROVEMENTS IN THE EIGHT SOLANO JURISDICTIONS: Help assure coordination and awareness of needed pedestrian improvements in City/County and STA planning efforts by:
 - a. Encourage PAC members to form relationships with City staff to identify and discuss priority projects in the respective jurisdiction PAC members represent
 - b. Encourage the use of data to inform decision-making
 - c. Supporting local and countywide pedestrian-planning efforts, which include current plans, such as the 2020 Active Transportation Plan Safe Routes to School Plan and upcoming Comprehensive Transportation Plan (CTP), and any city/county pedestrian planning efforts.

- d. Encourage pedestrian projects that incorporate All Ages and Abilities Design to increase access to pedestrian infrastructure for Solano residents of all ages and abilities.
- 4. CONTINUE GROWING PUBLIC AWARENESS OF THE PAC: Support with STA pedestrian outreach programs.
- 5. CONTINUE COORDINATING WITH THE BAC.

The 2025 Draft PAC Work Plan for the PAC (Attachment A) is available for review and will be up for action at the February 6, 2025 PAC meeting. STA staff request committee members to read and review the 2025 Draft PAC Work Plan.

Member-at-Large position

Background:

Under Article III, Section 1 of the PAC Bylaws states the following:

The STA Board of Directors shall determine membership of the PAC and appointment requirements. The PAC shall include a representative from each of the seven (7) Cities (Benicia, Dixon, Fairfield, Rio Vista, Suisun City, Vacaville, and Vallejo), the County of Solano, and three (3) members-at-large for a total membership of eleven (11).

Discussion:

Based on Article III, Section 1 of the PAC Bylaws, there are three (3) Member-at-Large, with one of them designated for a Bay Area Ridge Trail Representative, and the other for a Solano Community College representative. STA staff with the support of PAC committee members have been actively trying to recruit a member from the Solano Community College to fill in the position since and unfortunately has remained vacant since 2018.

A goal identified in the 2025 PAC Work Plan includes striving for full membership in the PAC, which includes filling the last remaining vacant position for the Solano Community College representative. In discussion with Chair Dooley and Vice Chair Green-Heffern, a solution that is being proposed is to convert the Solano Community College position into a Member-At-Large which will no longer limit the position to staff from the Solano Community College. Not only is this proposal well within the confines of the PAC Bylaws, but it will also be essential in filling the last remaining position for the PAC. This change opens up another opportunity for Solano residents to join the PAC and advocate for pedestrian improvements in their community.

With that being said, STA staff are recommending the PAC committee forward a recommendation to the STA Board to convert the Solano Community College position to a Member-at-Large position.
