4. COMMENTS FROM STAFF AND REPRESENTATIVES FROM ADVISORY COMMITTEES

- Kathrina Gregana shared the Solano Transportation Resiliency Plan (STRP). She discussed the STRP study's scope and the phases of public outreach. Kathrina Gregana disclosed that the upcoming community meetings and the STRP survey will be held virtually on August 21, 2025, from 6:00-7:30 p.m. In addition, she encouraged people to fill out the STRP survey and share it with others who have been affected by extreme weather in Solano County.
- Robert Guerrero commented that Suzanne Atone is no longer a program coordinator for Benicia/Vallejo School District, making Janelle Gregorio the interim coordinator.
- Amy Antunano noted that the new representative for the Benicia/Vallejo School District should be set up at the next SR2S meeting.

5. PRESENTATION

9. INFORMATIONAL ITEMS

A. SR2S Program Update

1. Rio Vista/Travis AFB/Vacaville School Districts

• Leigh Molianen summarized the events that happened over the summer and shared up coming events for Vacaville Library on September 6th and Walk and Roll to School Day on October 8th.

2. Dixon/Fairfield/Suisun City School Districts

- Crystal Preacher presented on the results from the Safe Moves Pedestrian Rodeo, Helmet Audit, Bay Area Bike Mobile, and FSUSD Back-To-School Resource Fair. In addition, she noted that SR2S will join parent-teacher related meetings throughout the school year.
- Ana Petero commented to keep reiterating to parents about guidelines for safety for motorized scooters and bicycles.
- Teri Booth announced the formation of the Ad Hoc E-Mobility Committee, comprised of members from the Pedestrian Advisory Committee and the Bicycle Advisory Committee.
- Jason Grey commented that at this point, the Ad hoc E-Mobility Committee is gathering statistics to form a recommendation.
- Jeff Henderson shared just from the law enforcement side, the SWITRS reporting has not updated to include electrified/powered in the language.
- Robert Guerrero noted to agendaize the topic of motorized vehicles used for active transportation for fact-finding and ordinances.

3. Benicia/Vallejo School Districts

Janelle Gregorio presented a verbal update on Solano County Library's Resource Fair for the City of Vallejo and shared the upcoming Back-to-School Night at Benicia High School on August 28^{th,} 2025

B. Enforcement Status Updates

1. Benicia Police Department

Alexandria Diosdado stated that there is a California vehicle code for motorized scooters, and the Community Service Officers can't formally stop the riders but can speak to the riders, breaking the code, once the riders make a stop. In addition, she shared that more children are wearing helmets. Alexandria Diosadado clarified that an electric bike without pedals needs a Class B permit, and handlebars cannot be above the face.

Michael Thomas emphasized educating children on safety and informing them of certain laws.

2. Suisun City Police Department

Jeff Henderson reported on the first week of school that children are using traditional bikes and with normal helmet ratios. In addition, he brought to light that during the weekdays, children bike safely for the most part, but during the weekends, children ride less safe. Jeff Henderson noted that the education for safety is working for the to and from school, but there needs to be a clear emphasis in general that safety is always required. He also shared that SCPD is not yet enforcing the daylighting law, but is in the process of being ready to roll out enforcement.

C. Solano Public Health (SPH)

Giselle Salinas Zavala presented that Solano Public Health was able to attend a kindergarten roundup event at La Clinica in Vallejo, SPH was able to distribute 98 bike helmets. She commented that SPH continues to distribute bike helmets for family health services and police departments.

D. Community Task Force Updates

1. City of Fairfield

Tina Machado shared the Engineering, Enforcement, and Education (3E) Committee, in which the discussion was about West Texas Street Construction and keeping people safe and businesses open. In addition, she noted that there is a notice prohibiting left turns onto and off from First Street to mitigate the impact on Fairview Elementary.

Fast Transit celebrated its 50th Anniversary, and FAST staff attended the Green Valley Back-to-School Night and informed parents about FAST services.

September is Pedestrian Safety Awareness Month, and there will be a collaboration between STA and FAST for the Be Seen Campaign.

The Fairfield Police Department purchased speed feedback trailers and let Tina Machado know about any high-priority roadways. The City of Fairfield is enforcing daylight law.

2. City of Vacaville

Ana Petero recommended using superintendents' letters and principals' newsletters to disseminate information.

Amy Antunano shared that she and Robert Guerrero will meet with the superintendents in Solano County to grow in partnership with the school districts.

Background:

Since 2008, the Solano Transportation Authority's (STA) Safe Routes to School (SR2S) Program has collaborated with all 7 cities and 7 school districts in Solano County to address safety concerns for students traveling to schools. The program's mission is to boost the number of children walking and biking to and from school by helping to make the journey safe, fun, and healthy by using a comprehensive approach, the program includes 6 "E's": education, encouragement, enforcement, engineering, engagement, and evaluation. The Program is available to all schools countywide and focuses on activities and programs that educate students on safety, health awareness and identify improvements within communities countywide to enhance active student travel safety financing projects that eliminate obstacles.

The Safe Routes to School (SR2S) program is primarily funded through the Metropolitan Transportation Commission's (MTC) One Bay Area Grant (OBAG). Additionally, the program leverages supplemental funding from smaller grants, including the Office of Traffic Safety (OTS) and the California Department of Public Health (CDPH) Kids Plate program. These combined funding sources support program activities aimed at enforcing traffic laws, educating the public about traffic safety, and implementing effective strategies to reduce fatalities, injuries, and economic losses caused by traffic collisions. The program also conducts public awareness campaigns and serves as a key traffic safety resource, engaging the public and media to promote traffic safety initiatives.

Discussion:

The SR2S Program staff recommends applying for \$350,000 in OTS grant funds and \$75,000 per year, totaling \$150,000 over two years, in CDPH Kids Plate funding. These two grants align with several of the SR2S Program's E's (Education, Encouragement, and Enforcement) and directly support the program's mission to provide pedestrian and bike safety education, encourage active transportation, and increase safety around schools for students.

If awarded this grant would allow the SR2S Program to use the funds to continue to work with these public safety partners, hold outreach events, and provide concentrated Pedestrian and bicycle safety education and enforcement in coordination with SR2S staff. These activities may include in-class presentations, school assembly presentations, bicycle rodeos, support for walking programs, Walk and Bike to School Day events, bike and pedestrian safety messaging, bike helmet enforcement, and support for crossing guard programs.

Fiscal Impact:

No matching funds are required for OTS or Kids Plate Grant Programs at this time.

RE: Solano Safe Routes to School (SR2S) Plan Update

Background:

The Solano Safe Routes to School (SR2S) Program encourages more students to walk and bike to school by promoting safe, enjoyable, and healthy travel options. The program takes a comprehensive approach through the Six E's: education, encouragement, enforcement, engineering, engagement, and evaluation. It is available to all schools countywide and focuses on safety education, health promotion, and community-wide infrastructure and program improvements to support active student travel.

The STA Board adopted Solano's first SR2S Plan in 2008, which guided the program until 2012. In 2013, an updated plan was adopted to further strengthen the program. Since 2023, STA staff and its consultant, have been working to update the Plan once again, with a focus on expanding youth engagement initiatives and increasing educational opportunities, particularly for disadvantaged communities.

Discussion:

The 2025 SR2S Plan Update is guided by the adopted Goals and Objectives framework. The Plan includes six primary goals related to improving student health, increasing safety and accessibility, reducing congestion and emissions, sustaining the program long-term, advancing equity, and strengthening local and regional partnerships. Progress toward these goals will be measured using enhanced program evaluation metrics included throughout the plan.

Over the past two years, STA staff collaborated with Solano Public Health, local jurisdictions, school districts, and existing SR2S Community Task Forces to develop the 2025 SR2S Plan Update. Engagement efforts included outreach to schools, community organizations, and city task forces to gather feedback, review current priorities, and assess program effectiveness. As part of the planning process, STA staff and consultants worked closely with each jurisdiction to confirm or reestablish local Community Task Forces, conduct priority project identification, and schedule walk audits in each district. Prioritized schools can be viewed in Attachment A.

The updated Plan introduces enhanced program evaluation metrics designed to track progress, measure outcomes, and assess the long-term effectiveness of SR2S programs and infrastructure investments. These metrics will help guide data-informed decisions and ensure accountability across jurisdictions while maintaining alignment with the Six E's framework.

As part of the final phase of the update, the draft Plan was released for a 30-day public comment period to allow community members, school partners, and local agencies to review and provide input. All feedback received during this period was reviewed and incorporated, as appropriate, and can be viewed in Attachment B.

The 2025 Safe Routes to School Plan has been completed and is available to view at the following link: 2025 SR2S Plan. This updated Plan presents a five-year vision for program and project implementation, integrates community feedback, identifies priority projects for each school district, and aligns future actions with SR2S goals and objectives.

STA staff are requesting SR2S-AC approval to forward a recommendation to the STA TAC and Board for the adoption of the final 2025 SR2S Plan.

Background:

The Safe Routes to School Advisory Committee (SR2S-AC) has two office positions, Chair and Vice Chair, to assist Solano Transportation Authority (STA) staff in developing agendas and running meetings. Under Article 5, Section 2 of the SR2S-AC Bylaws it states the SR2S-AC must select a Chair and Vice Chair at the last meeting of each calendar meeting.

The role of the Chair is to preside over SR2S-AC meetings and coordinate the meeting agendas with STA staff. The role of the Vice Chair is to assist the Chair and to preside over the meeting in the absence of the Chair. The Chair and Vice Chair serve one calendar year terms, while no officer is allowed to serve more than two consecutive terms in office. The new positions for Chair and Vice-Chair will be in effect starting February 18, 2026.

Discussion:

Chair Dan Healy, representing the Suisun City Police Department, and Vice Chair Tina Machado, representing the City of Fairfield, have served in their current position for the last calendar year and are eligible for reelection.

During their time as respective SR2S-AC Chair and Vice Chairs, they have overseen the approval of the Safe Routes to School Plan and have continued to support the SR2S program.

In accordance with the SR2S-AC Bylaws, STA staff recommends electing a Chair and Vice Chair to serve during the 2026 calendar year.

Background:

The Solano Safe Routes to School (SR2S) Program aims to increase the number of students walking and bicycling to school by promoting safe, healthy and accessible travel options. Employing an inclusive strategy, the program incorporates six key elements, often referred to as the 6 E's: education, encouragement, enforcement, engineering, engagement, and evaluation. The program supports schools countywide with activities and programs that educate students about safety, promote health awareness, and identify opportunities for community improvements ultimately enhancing safer travel for all.

Program Coordinator Updates:

- 1. Janelle Gregorio Countywide Events
 International Walk and Roll to School Day (W2SD) was held on Wednesday, October 8.
 Fifty schools across Solano County took part, encouraging students to begin their morning with an active and safe trip to school. An estimated 29,552 students participated, reflecting strong countywide engagement in promoting healthy travel habits.

For Ruby Bridges Walk to School Day on November 14, she is coordinating the delivery of student incentives for Riverview Elementary in Rio Vista and Joe Henderson Elementary in Benicia.

Leigh is also organizing a Community Bike Fair for Travis Unified School District. The event will be hosted by Golden West Middle School and will include participation from

Center Elementary and Vanden High School communities.

- 3. *Crystal Peacher Dixon and Fairfield-Suisun Unified School Districts*This fall, Crystal organized and supported a range of outreach and educational activities:
 - September 2 Giselle Salinas Zavala from Solano Public Health, attended David Weir Preparatory Academy's Back-to-School Night in Fairfield, on behalf of SR2S, providing program information to more than 75 families.
 - October 3 Crystal gave a presentation to Fairfield-Suisun Unified School District Administrators and staff on how SR2S programs can help improve attendance.
 - October 7 SR2S participated in Suisun City's National Night Out at Heritage Park, connecting with more than 150 community members.
 - October 23 A Safety Storytime was held at David Weir Preparatory for 92 kindergarten and first grade students, combining reading with pedestrian safety lessons. Later that day, Bay Area BikeMobile and the SR2S team provided free bike repairs for 16 students and distributed 16 helmets for riders in need.
 - October 24 John Knight Middle in Dixon hosted a bike mobile event where 18 bikes were serviced, and 13 helmets were distributed to riders in need.
 - November 14 Fairview Elementary hosted a Pedestrian Rodeo Assembly where 75 students took part in hands-on safety activities and lessons.

Helmet audits were also completed Tremont Elementary and Dixon Montessori Charter in Dixon, as well as Fairfield High and David Weir Preparator in Fairfield. Follow-up audits are planned for May to measure program outcomes.

4. Jayme Ziadeh – Vacaville and Vallejo City Unified School Districts

SR2S welcomed Jayme Ziadeh to the program in September. Since joining, she has completed four helmet audits; two in Vallejo at Hogan Middle and Glen Cove Elementary, and two in Vacaville at Vaca Pena Middle and Orchard Elementary.

Jayme is currently building relationships with schools and district staff in her areas while shadowing other coordinators to learn program procedures. She is scheduled to table at her first event on November 5 at Vallejo Charter's STEAM Night.
