- Mayor Hernandez commented that during the LNU evacuation mandates for Fairfield residents, key roadways were temporarily congested, such as Petersen Road, Walters, and Highway 12. In the event of a future evacuation impacting both Fairfield and Suisun City residents, there would be a need for alternative routes to be accessed to facilitate the evacuation of residents from both cities. In response, Mr. Lin stated that a project is currently in the design phase to construct a road that would provide access from the Air Force Base to Creed Road.
- Mayor Okamura inquired whether any roadways around Travis Air Force Base qualified for the Defense Access Road (DAR) Program. Mr. Campbell commented that at this moment, the Travis Air Force Base did not have any DAR-designated roads, however, the program continues to be monitored for potential future opportunities.
