1. CALL TO ORDER/SELF INTRODUCTIONS

The meeting of the STA's Bicycle Advisory Committee (BAC) was called to order by Chair Segala at approximately 6:28 p.m. at the STA in Conference Room 1.

2. CONFIRM QUORUM

Quorum was confirmed.

3. APPROVAL OF THE AGENDA

On a motion by David Pyle and a second by Lori Wilson, the BAC approved the agenda.

4. OPPORTUNITY FOR PUBLIC COMMENT

Zoe Zaldivar indicated that the STA Board and Advisory schedule and Attendance Matrix was under separate cover for this meeting, and should be included in all future BAC Packets.

5. CONSENT CALENDAR

A. Recommendation:

Approve STA BAC Meeting Minutes of January 7, 2016.

On a motion by David Pyle, and a second by Jim Fisk, the BAC approved the minutes of January 7, 2016. (5 Ayes, 2 Absent, 1 Abstention)

6. ACTION NON - FINANCIAL

7. INFORMATION DISCUSSION

A. Funding Priorities: TDA Article 3 & OBAG Cycle 2

Drew Hart presented the fundamentals of Transportation Development Act (TDA) Article 3 and One Bay Area Grant (OBAG) Cycle 2 and how it relates to the factors of prioritizing funding, deliverability, geographic equity, and urgency on projects that the Bicycle Advisory Committee reviews for funding opportunities. He noted that in the upcoming months, the BAC will have the opportunity to review and discuss projects for multiple funding opportunities, specifically TDA Article 3 and OBAG 2. He conveyed the collaborative effort between the BAC, Pedestrian Advisory Committee (PAC), STA staff, and the appropriate public works and planning staff from each jurisdiction to determine the projects with highest priority for these funding sources. the BAC and PAC then make recommendations to the STA Board to allocate TDA Article 3 funding for bicycle and pedestrian projects based on the developed priority lists. He further explained that an annual review of the projects lists are conducted to ensure that the lists are up to date as projects are completed and priorities change at the local level.

Mr. Hart implied that STA staff plans to recommend an OBAG 2 process for Solano County which will be similar to the original OBAG project review and selection process. He also noted that currently, there is an estimated \$204,000 in TDA Article 3 funds available to STA which has carried over from previous years. He outlined that on average, STA receives \$300,000 each fiscal year bringing the available total to a projected amount of about \$500,000 for fiscal year 2016-17. Mr. Hart summarized that as these two opportunities near, the BAC should work to identify top priority projects to be recommended for funding from these program sources. As such he suggested that BAC members ought to consult their local public works department to coordinate the advocacy and funding plan for each jurisdiction's top project.

B. Public Outreach and CTP Update

Drew Hart stated that the STA began doing public outreach for the Comprehensive Transportation Plan (CTP) in 2015. He summarized that this outreach began with a series of meetings with public interest groups such as Rotary clubs and Chambers of Commerce and in late 2015. STA desires to connect with the public and identify the priorities of residents in Solano County. He noted that STA send out approximately 50,000 mailers to registered Solano County voters in February of 2016 in an effort to solicit additional input and promote the Telephone Town Halls. He relayed that the mailers included a tear off sheet with prepaid postage, with an invitation for residents to leave comments by e-mail or with a phone survey; total responses to this effort exceeded 2,000.

Mr. Hart outlined that the two activities with the greatest participation were the mail in cards and the Telephone Town Hall meetings. He summarized that as of this date, more than 1,300 cards have been mailed in, with their main concerns focusing on the maintenance of local streets and roads, road safety, transportation for seniors and people with disabilities, as well as the accountability of government when it comes to spending transportation and other funds. He highlighted that the Telephone Town Halls, which were held between 6:00 and 7:00 PM on the nights of February 8th, 9th, and the 16th, included all seven mayors, and three of the five county supervisors. He noted that almost 2,000 people called in to listen, and 61 people had a chance to ask questions and receive an answer during these meetings. Mr. Hart concluded that the information received in these various outreach efforts will help guide STA in finalizing the prioritization of projects and programs funding the transit and rideshare and arterials, highways and freeway elements of the Solano comprehensive transportation plan with the One Bay Area Grant (OBAG) second cycle.

C. Bike Counters Update

Ryan Dodge provided an update on the eight portable automated counters (four bicycle and four pedestrian) purchased in March, 2015 for the purpose of collecting continuous volume count data throughout Solano County and the seven cities. He relayed the importance that volume count data has and that it will be collected and used primarily for competitive grant applications, to collect before-data for funded projects, to collect after-data to help evaluate the effectiveness of implemented projects, and to assist the STA BAC and the STA PAC in prioritizing future projects. He stipulated that these counters will be available for use on a first-come-first-serve basis, and will be used to continually provide information as it comes forward, to the committees.

D. Funding Opportunities: ATP, BAAQMD, YSAQMD

Drew Hart explained that the Active Transportation Program (ATP) is a statewide funding program for bicycle and pedestrian projects. He noted that the program aims to promote projects to increase biking and walking trips and that the grant program is highly competitive with over \$1 billion in requests for \$360 million in funds for each Cycle 1 and Cycle 2. He stated that STA's Safe Routes to School application was successful in receiving awards in both Cycle 1 and Cycle 2. He noted that the partnership between STA with the Cities of Benicia, Rio Vista and Vallejo was key to the success in Cycle 2. He summarized that both Safe Routes to School grants are currently being implemented. Mr. Hart conveyed on behalf of STA the identified project for submitting an application for Cycle 3 ATP funding – the Bay Trail/Vine Trail Gap Closure Project in Vallejo. He highlighted the fact that STA had previously submitted an application for the Bay Trail/Vine Trail in Cycle 2, and that this application would be reviewed, adjusted, and strengthened before being resubmitted for Cycle 3. He answered committee members' inquiries that this application has an anticipated due date of June 15, 2016.

Drew Hart specified that the Bay Area Air Quality Management District (BAAQMD) Transportation Fund for Clean Air (TFCA) 40% Program Manager Funds are administered by STA for Solano County. He relayed that eligible TFCA projects are those that reduce air pollution from motor vehicles. He highlighted that those in the western portion of Solano County are located in the Bay Area Air Basin and are therefore eligible to apply for those funds. He stated that this area includes the cities of Benicia, Fairfield, Suisun City, and Vallejo.

Mr. Hart summarized that the Yolo-Solano Air Quality Management District (YSAQMD) provides similar funding by way of the Clean Air Funds Program for the remaining cities of Dixon, Rio Vista and Vacaville and the unincorporated County within the Yolo-Solano Air Basin. He noted that YSAQMD recently released a call for projects for the Clean Air Funds Program and \$332,000 is available this year, with applications due by March 25, 2016.

He announced that it is anticipated that STA will receive \$340,664 in TFCA Program Manager Funds for 2016-17. Additionally Mr. Hart noted that STA staff plans to submit an application for the Solano Bike Map and Wayfinding Program from the YSAQMD available funds.

RE: Bicycle Infrastructure Presentation

Background:

Bicycle infrastructure provides space for safe and proper bicycle travel. This can be in the forms of, but not limited to, bicycle paths separate from vehicular roadway, bike lanes within the roadway, and sharrows which communicate to bikes and drivers where to expect bikes and cars to mix. The state of California classifies these as Class I, Class II, and Class III, respectively. Other bicycle infrastructure and treatments, such as bike boxes, green paint, and protected intersections increase the safety of cyclists. These infrastructure and treatments are an ever-expanding field.

Discussion:

The Executive Director at STA has requested a presentation be given to the STA Technical Advisory Committee (TAC) to review the many bike infrastructure options, and the state of the art practices. It was requested to first be presented to the BAC before being presented to the TAC later this month.

STA staff will present more on this topic at the BAC meeting on May 5, 2016.

RE: Funding Recommendations Meeting

Background:

The Bicycle Priority Projects List and Pedestrian Priority Project List are developed through a collaborative effort between the Bicycle Advisory Committee and Pedestrian Advisory Committee (BAC or PAC), STA staff, and public works and planning staff from the member agencies. This creates a prioritized list from which STA staff, the BAC and PAC can make funding recommendations to the STA Board.

An annual review of the Projects List is conducted to ensure that the list is up to date as projects are completed and priorities change at the local level.

It is worth noting the timeliness of this opportunity. One Bay Area Grant Cycle 2 (OBAG 2) funding is on a 5 year cycle. This is a chance to survey the projects on the horizon, and establish a comprehensive funding strategy. Projects with smaller needs will be paired up with smaller funding programs which occur more regularly funds like Transportation Development Act (TDA) Article 3 or funds from the air districts. A few larger projects will be slated to be funded by OBAG.

It is also relevant to point out that TDA Article 3 funds can be banked from year to year. If a project with a larger need is identified a few years out, the BAC and the PAC can recommend rolling over funds in order to save a larger amount.

Discussion:

It is time for the BAC to update the Priority Project Lists. This list will be recommended to the STA TAC and Board for approval. Further, the list will set the priority for which projects get recommended for funding in the upcoming funding cycle.

STA staff recommends a special meeting at the first of June. The meeting can combine with the STA PAC meeting on the evening of June 2nd, or if a combined meeting is not desired, another date may be selected by the committee.

7.D Bike to Work Day:

Bike to Work Day is Thursday, May 12, 2016. Bike to Work events will take place throughout the month of May including a Team Bike Challenge and Bike Commuter of the Year Awards. Energizer stations will be set up throughout Solano and Napa counties on Bike to Work Day. A list of the 16 energizer stations are listed on commuterinfo.net

7.E District 4 Highway Bike Map:

Caltrans District 4 is developing the Caltrans District 4 State Highway System Bike Map (District 4 Bike Map), which covers the State Highway System within the nine Bay Area counties. The purpose of the District 4 Bike Map is to show which state routes are available to bicyclists and, for freeways or sections thereof where bicycling is prohibited, an alternate route available to bicyclists. A Draft District 4 Bike Map is now available for city/county agencies and stakeholders to review and provide feedback. This is a public draft, so please feel free to share with the awareness that information in this map is not final and subject to revisions.

We are asking for input on accuracy and selection of alternate routes identified (where bicycling is prohibited on a state route) and general map usability and features. Alternate routes have been identified based on quality of existing facilities and directness of an alternate route parallel to a state route. Given the complexity of existing networks, alternate bike routes may or may not always align with or be parallel to the state route and identification of such a route is not always obvious. To view alternate routes, click on the Layers List icon near the top right to toggle the Alternate Routes layer.

7.F Pleasants Valley Road Status Update:

Solano County Board of Supervisors unanimously supported the Pleasants Valley Road safety project on April 26, 2016. A few BAC members were in attendance and voiced their support for the project during public comment period. A further update will be provided at the meeting.

7.G Summer Bike Tour:

In previous years, STA staff has organized a Bicycle Projects Tour for the Bicycle Advisory Committee (PAC) in order to familiarize new and veteran members with the status of countywide bicycle projects. Should the BAC decide there is interest and availability for a tour, a date should be decided on in the near future to provide STA staff with sufficient time to arrange stops with project sponsors.

7.H Highway 37 Sign Update:

At previous BAC meetings, committee members and public have inquired about the signage on the entrance to Highway 37 in Vallejo which prohibits cyclists despite the separated path identified for bicycle use. STA staff made another attempt to resolve this issue with Caltrans. As of an email dated March 4, 2016, Caltrans staff stated a work order is in place to have the sign revised so bicycles are not prohibited on that onramp. STA staff has not confirmed if the work has been performed to date.

Section 1. Meetings/Attendance (Bylaws)

The BAC shall hold a regular meeting at least once a calendar year quarter and as necessary to fulfill the mandate of Article III, Sections 1 and 2. Members of the BAC that do not attend three scheduled meetings in succession and do not contact staff to indicate that they will not be present is considered to be an ‘un-contacted absence’ which may have their position declared vacant by the STA Board. Absence after contacting staff is considered a ‘contacted absence.’ Contacted absences and un-contacted absences shall be documented in the minutes of each meeting. If a BAC member has missed a combination of four contacted and un-contacted absences in any one-year period, he or she will be sent a written notice of intent to declare the position vacant. If there is no adequate response before or at the next scheduled meeting, and based upon a recommendation from the BAC, the position may be declared vacant by the STA Board.
