Richard Burnett provided an update to the committee members regarding various updates at the Metropolitan Transportation Commission (MTC). Mr. Burnett will send a link to Sheila Ernst regarding the lifeline transportation, investments and land use.

Edith Thomas stated that a Solano Seniors and People with Disabilities Transportation Advisory Committee met on September 15th to discuss OBAG 2 priorities. She stated that the priority projects were to continue funding the mobility call center and mobility management contracts and a vehicle rideshare program.

Ernest Rogers was not present to provide a CTSA-AC update.

8. ACTION ITEM

A. Fiscal Year (FY) 2016-17 Transportation Development Act (TDA) Claims for the City of Fairfield/Suisun City

Liz Niedziela provided an overview of the Fiscal Year (FY) 2016-17 TDA claims for the City of Fairfield and the City of Suisun City. She explained that TDA funding is used for public transit services, transportation for seniors and people with disabilities, regional transportation planning, and bicycle and pedestrian programs. Ms. Niedziela outlined the TDA claims being brought forward for recommendation for approval and reviewed the TDA matrix for FY 2016-17 which will be submitted to the STA Board for approval on September 14, 2016.

Richard Burnett asked for clarification on intercity bus replacement and upgrades.

Liz Niedziela will provide that information via email.

Recommendation:

Forward a recommendation to MTC to approve the City of Fairfield/Suisun City's FY 2016-17 TDA Claim for \$6,510,722 for transit operations and capital needs.

With a motion by Edith Thomas and a second by James Williams, the PCC approved the recommendation. (9 Ayes, 1 Absent)

B. One Bay Area Grant (OBAG) Round 2 Discussion

Liz Niedziela provided an update on the One Bay Area Grant (OBAG) Round 2 funding. She explained that at the May 2016 meeting, the PCC Chairperson appointed Lyall Abbott, Rachel Ford, and Ernest Rogers to represent the PCC at the OBAG 2 workshop.

The PCC confirmed that Rachel Ford will be representing the PCC at the OBAG 2 workshop as Ernest Rogers and Lyall Abbott are unable to attend.

The PCC took a silent vote on the priority projects that were proposed and selected by the CTSA-AC and selected the following projects in the order as follows:

(1) Solano Mobility Call Center, (2) Vehicle Rideshare program, (3) Travel Training, with honorable mention to (4) Accessible Vallejo bus stops, (5) West Texas Gateway project.

Recommendation:

Identify and recommend priority projects for One Bay Area Grant (OBAG) 2 funding.

RE: PCC Membership Reassignment and Appointment

Background:

Paratransit Coordinating Council (PCC) is a citizen's advisory committee to the Solano Transportation Authority (STA) that represents the seniors, people of disabilities and low-income residents of Solano County. The members of the PCC are volunteers from the local community and local social service agencies. The term of service on the Council shall be three years. A member may continue to serve through reappointment by the STA Board.

The Solano Transportation Authority's (STA) Paratransit Coordination Council (PCC) By-Laws stipulate that there are eleven members on the PCC. Members of the PCC include up to three (3) transit users, two (2) members-at-large, two (2) public agency representatives, three (3) social service providers and one (1) representative from MTC Policy Advisor Council as shown below.

- 1) Voting Members (11)
 - a) Transit Users (3)
 - i) Elderly (1) (60 or older)
 - ii) Handicapped (1)
 - iii) Low Income (1)
 - b) Members at Large (2)
 - c) Public Agencies (2)
 - i) County Department of Health and Social Services (1)
 - ii) Education –Related Services (1)
 - d) Social Service Providers (3)
 - i) Three Council members will be selected from agencies experienced in the provision of services for the physically disabled, the elderly, and those in rural areas; when possible, social service providers of transportation. Every effort will be made to ensure that the needs and perspectives of both non-profit and for-profit providers are adequately represented in this section of the Council.
 - e) The Policy Advisory Council MTC Advisor for Solano County.

Discussion:

Curtis Cole's PCC term expired September 2016 and he was not interested in seeking reappointment. This created a vacancy for public agency – County Department of Health and Social Services representation on the PCC (Attachment A). STA received an interest form from Lisa Hooks Staff Services Manager II, Regional Manager for State Council on Developmental Disabilities located in Vallejo (Attachment B). Lisa has attended PCC meetings and is interested in becoming a PCC member. However, the only opening the PCC has is for Public Agency – County Department of Health and Social Services.

Rachel Ford was appointed to the PCC as a Social Service Provider but she is employed by Solano County Department of Health and Social Services. STA staff is presenting the option to reassign Rachel Ford's PCC representation from Social Service Provider to Public Agency – County Department of Health and Social Services. This reassignment will provide an opening for Social Service Provider, allowing Lisa Hooks' application to be considered by the PCC.

Recommendations:

- 1. Forward a recommendation to the STA Board to reassign Rachel Ford PCC representation from Social Service Provider to Public Agency County Department of Health and Social Services.
- 2. Forward a recommendation to the STA Board to appoint Lisa Hooks to the PCC for a three year term as a Social Service Provider.

The Paratransit Coordinating Council (PCC) approved the 2016 PCC Work Plan at the March 2016 PCC meeting.
