# 6. COMMENTS FROM STAFF AND REPRESENTATIVES FROM THE PARATRANSIT COORDINATING COUNCIL

- 1. Richard Burnett, MTC/PAC Representative provided an update to the committee members regarding various updates at the Metropolitan Transportation Commission (MTC).
- 2. Vacant, Seniors & People with Disabilities TAC Representative. Liz Niedziela stated that currently there is not a meeting scheduled for the Solano Seniors and People Disabilities TAC to meet.

Dixon Mobility Senior Summit fliers were handed out to each PCC member.

3. Ernest Rogers, Consolidated Transportation Services Agency Advisory Committee (CTSA-AC) Representative, announced that the next CTSA-AC meeting will be held next Thursday, September 28, 2017 at the Government County Building, located at 675 Texas Street in Fairfield.

#### 7. PRESENTATIONS

### A. Clipper Card Information

Amy Antunano provided a presentation on Clipper Card service. She explained that the senior clipper card provides transit discounts of 50% for anyone 65 years of age or over and it does not expire. She added that there is no charge for the Senior Clipper card. Ms. Antunano explained that the Regional Transit Connection Card (RTC) is discounted fare for those with a disability for \$3.00. She added that in order to qualify, the user must have a Medicare Card, DMV disability placard, or Medical Certification. Ms. Antunano concluded her presentation with next steps for Clipper 2.0.

Chair Rogers asked for clarification on why "technology is not a solution". Amy Antunano with follow up with a Clipper representative and get back to the committee.

#### B. First/Last Mile Shuttle Update

Sean Hurley provided a presentation on the First/Last Mile Shuttle pilot. He explained that Solano County approached the STA regarding a transportation gap that exists between the County of Solano Health and Social Services Building and the Suisun/Fairfield Train Station. Mr. Hurley outlined that results regarding a survey that was provided to the employees of Solano County Health and Social Services and the Jelly Belly that was conducted in October 2016.

Liz Niedziela explained that TDA funds are shared among agencies to fund joint services such as SolanoExpress intercity bus routes and Intercity Taxi Scrip Program. She stated that the STA works with the transit operators and prepares an annual TDA matrix to clarify how the TDA funds are to be allocated each year among the local agencies and to identify the purpose of the funds.

The group discussed TDA program funding designation amounts for each of the cities.

#### Recommendations:

Review and forward a recommendation to MTC to approve:

- 1. The City of Dixon's FY 2017-18 TDA Claim for \$736,537 for operating and capital projects.
- 2. The City of Fairfield's FY 2017-18 TDA Claim for \$5,319,799 for operating and capital projects.
- 3. The City of Vacaville's FY 2017-18 TDA Claim for \$3,699,551 for operating, capital and planning and administration.
- 4. The City of Rio Vista's FY 2017-18 TDA Claim for \$334,268 for operating and capital projects.

With a motion by James Williams and a second by Rachel Ford, the PCC approved the recommendations. (7 Ayes, 2 Absent)

Liz Niedziela provided a brief update on the PCC membership. She explained that Kenneth Grover was not present at that meeting, but has since confirmed he would like to be reappointed. She stated that Cindy Hayes from Independent Living Resources has confirmed interest in serving as a Social Services Provider member on the PCC and has submitted an interest form.

#### Recommendations:

- 2. Forward a recommendation to the STA Board to appoint Cindy Hayes for a three (3) year term as Social Services Provider member to the PCC.

for the City of Rio Vista

#### **Background:**

The Transportation Development Act (TDA) was enacted in 1971 by the California Legislature to ensure a continuing statewide commitment to public transportation. This law imposes a one-quarter-cent tax on retail sales within each county for this purpose. Proceeds are returned to counties based upon the amount of taxes collected, and are apportioned within the county based on population. To obtain TDA funds, local jurisdictions must submit requests to regional transportation agencies that review the claims for consistency with TDA requirements. Solano County agencies submit TDA claims to the Metropolitan Transportation Commission (MTC), the Regional Transportation Planning Agency (RTPA) for the nine Bay Area counties.

TDA funding is used for public transit services, transportation for seniors and people with disabilities, regional transportation planning, and bicycle and pedestrian programs. MTC requires agencies to have public review of the TDA Article 4 & 8 claims by the Paratransit Coordinating Council (PCC) before they can be approved. However, MTC is not obligated to the recommendations made by the PCC.

#### **Discussion:**

TDA funds are shared among agencies to fund joint services such as SolanoExpress intercity bus routes and Intercity Taxi Scrip Program. To clarify how the TDA funds are to be allocated each year among the local agencies and to identify the purpose of the funds, the STA works with the transit operators and prepares an annual TDA matrix. The TDA matrix is approved by the STA Board and submitted to MTC to provide MTC guidance when reviewing individual TDA claims. The TDA matrix for FY 2017-18 will be submitted to the STA Board for approval on December 13, 2017.

As required by MTC Resolution 1209, the City of Rio Vista is submitting their FY 2017-18 Revised Transportation Development Act (TDA) Article 8 claim for consideration by the PCC.

The Revised TDA claim for Rio Vista is being brought forward for PCC review:

### City of Rio Vista

In the City of Rio Vista initial TDA claim, they were requesting \$411,811 in TDA funds which includes \$334,268 in their local TDA funds, \$65,000 from the City of Dixon TDA funds, and \$12,543 from the SolTrans TDA funds. The \$65,000 from the City of Dixon, to be used for operations, was authorized by the STA Board on May 10, 2017. The action authorized Rio Vista to claim \$65,000 against Dixon's Intercity Bus Replacement TDA reserves, following

Rio Vista's unsuccessful FTA 5310 application. The \$12,543 from SolTrans completes swaps of LCTOP funds from FY 2015-16 and FY2016-17, and will be used for operating. The City of Rio Vista's TDA funds in the amount of \$315,968 will be used for operating, and \$18,300 will be used for capital projects. The City of Rio Vista's capital project includes:

• \$18,300 for the local match for one vehicle replacement

The City of Rio Vista is requesting an additional \$36,656 for operating expense increasing the total claim amount to \$448,467. Rio Vista also identified \$90,900 to be used for administration and planning that will be deducted from their operation expense.

The City of Rio Vista's TDA Claim will be consistent with the TDA matrix going to the STA Board for approval on December 13, 2017.

Review and forward a recommendation to MTC to approve:

1. The City of Rio Vista's FY 2017-18 TDA Claim for \$448,467 for operating, capital and planning and administration projects.

#### **Background:**

The Paratransit Coordinating Council (PCC) approved the 2017 PCC Work Plan at the January 2017 PCC meeting.
