3. APPROVAL OF THE AGENDA

6. CONSENT CALENDAR

A. Minutes of the STA PAC Meeting of October 6, 2016

On a motion by Kevin McNamara, and with a second from Pete Turner, the STA PAC approved the minutes of October 6, 2016 unanimously (4 Ayes, 3 Absences, 0 Abstentions).

7. PRESENTATIONS

A. Benicia Urban Waterfront Enhancement and Master Plan

Victor Randall presented on one of the City of Benicia's priority project, the Benicia Urban Waterfront Enhancement and Master Plan, with a power point which is available upon request. Please contact Ryan Dodge at rdodge@sta.ca.gov for further details and a copy of the power point.

Teresa Booth inquired if the construction of the boardwalk at the eastern end of the park, adjacent to enhanced seasonal wetlands, would interfere with the bird migration. Victor Randall noted Ms. Booth's comment and will include her environmental concerns for this project.

Pete Turner asked if the kayak launch site was included in the Benicia Urban Waterfront Enhancement and Master Plan. Victor Randall responded that kayak launch sites were not included in the plans because of exposed mud flats during low tides. Mr. Randall indicated that the 9th Street Park is a designated Water Trail launch site. Victor Randall also mentioned that there may be future plans for additional Water Trail launch sites. Mr. Randall highlighted how the Benicia Waterfront area is unique because it is the only location in Solano County that both a Priority Development Area as well as a Priority Conservation Area given that both the San Francisco Bay Trail and the Bay Area Ridge Trail connects to this area.

Victor Randall reviewed the multiple phases of the Benicia Urban Waterfront Enhancement Master Plan. Drew Hart requested for the estimated cost of this project. Mr. Randall responded that the current working estimate is \$6.7 million including environmental cost, design work, and construction, but not including contingency.

Victor Randall added that Park Dedication funding will assist with environmental costs as well as art being integrated into the waterfront area. Drew Hart mentioned that an additional source of funding that the PAC members make recommendations for is TDA Article 3. Mr. Hart proposed that in a future PAC meeting, this project be included in projects considered for TDA Article 3 funds.

Victor Randall added that he is in the process of registering the Benicia waterfront area as a historical location. PAC members agreed that when this project is complete, the Benicia waterfront will be one of the gems of Solano County because of its beautiful location and historical significance.

Victor Randall departed at approximately 6:30 p.m.

A. One Bay Area Grant (OBAG) Cycle 2 Congestion Mitigation and Air Quality (CMAQ) Call for Projects Applications Received

Drew Hart presented in place of Ryan Dodge concerning the One Bay Area Grant (OBAG) Cycle 2 Congestion Mitigation and Air Quality (CMAQ) Call for Projects Applications Received. Mr. Hart reviewed OBAG as a regional funding program for federal transportation dollars distributed to Bay Area Congestion Management Agencies (CMAs) every five years.

Drew Hart summarized how the STA Board on September 14, 2016 issued a Call for Projects for \$4,646,003 of OBAG 2 CMAQ funds to be distributed on a competitive basis. Applications received will be reviewed by STA staff using the criteria approved by the STA Board at the same meeting. Mr. Hart noted that CMAQ funds are available for projects that reduce air pollution such as bike and pedestrian facilities, and encouraging the use of public transit.

Drew Hart stated that the Call for Projects opened on September 15, 2016 and closed on November 18, 2016.

Mr. Hart reviewed the previous PAC meeting on October 6, 2016 where the committee members recommended the City of Suisun City Lotz Way Class I Bikeway / Multi-Use Path Project as their priority project for implementation. The PAC designated Kevin McNamara, Chair, to present to the STA Board at the October 12, 2016 informational workshop to advocate for this project. Drew Hart indicated that the City of Suisun is requesting \$752,500 for the Suisun City Lotz Way project from CMAQ and the local contribution is 11%.

PAC members discussed all the different projects from the STA OBAG Cycle 2 Project Submittals and Pete Turner request more information on the Solano County Fairgrounds Drive Project to be provided during the next PAC meeting.

Drew Hart announced that STA staff will report to the STA Board at the December 14, 2016 meeting a similar summary, tentatively recommend specific projects for funding to the STA Board at the January 11, 2017 meeting, and final project funding approval is tentatively anticipated at the February 8, 2017 STA Board meeting.

Drew Hart mentioned that both the PAC and BAC will review their Tier 1 and Tier 2 projects around Spring and see if there is a need to reprioritize which project to recommend for the TDA Article 3 funds.

Teresa Booth proposed to schedule a joint PAC and BAC meeting next year. Pete Turner indicated that the PAC and BAC joint meetings are not very productive due to one committee primarily focusing on their projects and not as a collective group. Mr. Turner recommended BAC members to email their concerns to PAC members as an alternative option to scheduling a joint meeting.

Background:

The Solano Transportation Authority (STA) purchased eight portable automated counters (four bicycle and four pedestrian) in March, 2015 for the purpose of collecting continuous volume count data throughout Solano County and the seven cities.

Volume count data will be collected and used primarily for competitive grant applications, to collect before-data for funded projects, to collect after-data to help evaluate the effectiveness of implemented projects, and to assist the STA Bicycle Advisory Committee (BAC) and the STA Pedestrian Advisory Committee (PAC) in prioritizing future projects. Counters are available for use on a first-come-first-serve basis (see Attachment A. STA Automated Counter User Agreement).

Discussion:

STA staff has coordinated the installation of automated counters at eight locations and has counted people walking, biking, or rolling the past two years:

Section 1. Meetings/Attendance (Bylaws)

The PAC shall hold a regular meeting at least once a calendar year quarter and as necessary to fulfill the mandate of Article III, Sections 1 and 2. Members of the PAC that do not attend three scheduled meetings in succession and do not contact staff to indicate that they will not be present is considered to be an 'un-contacted absence' and may have their position declared vacant by the STA Board of Directors. Absence after contacting staff is considered a 'contacted absence.' Contacted absences and un-contacted absences shall be documented in the minutes of each meeting. If a PAC member has missed a combination of four contacted and un-contacted absences in any one-year period, he or she will be sent a written notice of intent to declare the position vacant. If there is no adequate response before or at the next scheduled meeting, and based upon a recommendation from the PAC, the position may be declared vacant by the STA Board.
